## ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (GRANFEST) (SANGRE GRANDE) ORDER, 1996

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Granfest) (Sangre Grande) Order, 1996.
- 2. This Order comes into operation on Saturday, 3rd August, 1996 and Commencement and has effect between the hours of 9.00 a.m. and 12.00 midnight.
  - 3. Parking is prohibited on the following roads:

Parking prohibited

- (a) Eastern Main Road, between Ramdass Street and Savi Street:
- (b) Picton Road, from Eastern Main Road and Ojoe Road;
- (c) Adventist Street, between Picton Road and Ojoe Road;
- (d) Foster Road, between Henderson Street and Toco Road;
- (e) Ojoe Road, between Adventist Street and Sangre Grande Roundabout:
- (f) Brierley Street, between Toco Road and Picton Road;
- (g) Savi Street and Boodooville;
- (h) Paul Street;
- (i) Henderson Street;
- (j) River Street, between Foster Road and Ojoe Road.
- 4. (1) Maxi-taxis plying from Sangre Grande to Arima/Port-of-Maxi-taxi and Spain, shall park and stand for hire on Co-operative Street on the taxi stands eastern side facing south.
  - (2) Taxis plying—
    - (a) from Sangre Grande to Port-of-Spain, shall park and stand for hire on the Eastern Main Road, west of Co-operative Street facing west on the southern side of the road;
    - (b) the Manzanilla/Mayaro and Fishing Pond routes, shall park and stand for hire east of Boodooville Circular along the Eastern Main Road facing east on the northern side of the road;

- (c) from Sangre Grande to Matura, Toco and Matelot, shall park and stand for hire on the northern side of Toco Road, east of Brierley Street facing east;
- (d) between Biche and Sangre Grande, shall park and stand for hire on the eastern side of Cunapo Southern Road, south of Mary Street facing south;
- (e) the hospital route, shall park and stand for hire on the western side of Foster Road, north of River Street facing north.

Vehicular routes

- 5. Vehicular traffic proceeding—
  - (a) east along the Eastern Main Road, shall be diverted north into Picton Road, east along Adventist Street, north along Ojoe Road, east into Neil Street into Sukhram Village Street, south along Foster Road, east into Brierley Street, south into Savi Street and into Boodooville;
  - (b) west along the Eastern Main Road, shall be diverted north into Savi Street, west along Toco Road, north along Henderson Street into River Street, north along Ojoe Road, west along Adventist Street, south along Picton Road and west along Railway Road;
  - (c) north along the Cunapo Southern Road towards the Eastern Main Road, shall proceed west into Juteram Street, north along Paul Street and west into the Eastern Main Road;
  - (d) into Cunapo Southern Road, shall proceed east along the eastern Main Road, south into Paul Street, east into Juteram and into Cunapo Southern Road.

Public Transport Service Corporation buses 6. Public Transport Service Corporation Buses operating from Arima, shall approach the Public Transport Service Corporation Terminus in Sangre Grande via Picton Road and Brierley Street.

Removal and impounding of vehicles unlawfully parked

7. Without préjudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
