ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(SIPARIA KI MAI CELEBRATIONS) ORDER, 1995

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Ki Mai Celebrations) Order, 1995.
2. This Order has effect between the hours of 3.00 p.m. on Duration Thursday, 13th April, 1995 and 12.00 noon on Friday, 14th April, 1995.
3. Vehicular traffic is prohibited on the following roads: Roads Closed
 - (a) George Street, between Edward Street and La Pastora Street;
 - (b) Mary Street, between Edward Street and La Pastora Street;
 - (c) La Pastora Street, between Victoria Street and Siparia-Erin Road.
4. Between the hours of 6.00 p.m. on Thursday, 13th April, 1995 Traffic Routes and 12.00 noon on Friday, 14th April, 1995 vehicular traffic shall proceed along the following routes:
 - (a) in a westerly direction only, along the Siparia-Erin Road, between Edward Street and La Pastora Street;
 - (b) vehicles approaching Siparia from Erin proceeding towards San Fernando, shall turn north into Siparia Road, east into Gambal Street, onto Grell Street and east onto the Siparia-Erin Road;
 - (c) vehicles approaching Siparia from Fyzabad along the Siparia Road, shall turn east into De Gannes Lane, south into Coora Road and east or west into Siparia-Erin Road.
5. Parking is prohibited on the following roads: No parking
 - (a) De Gannes Lane;
 - (b) Victoria Street, between Coora Road and La Pastora Street;
 - (c) Siparia Road, between Potter Lane and Siparia-Erin Road;

- (d) Siparia-Erin Road, between La Pastora Street and Logie Street;
- (e) Edward Street, between Mary Street and Siparia-Erin Road;
- (f) Mary Street, between Station Street and Coora Road;
- (g) La Pastora Street.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
