MADE BY THE MINISTER OF WORKS AND TRANSPORT UNDER SECTION 65
OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE MISCELLANEOUS ROAD TRAFFIC (AMENDMENT)
ORDER, 2017

1. This Order may be cited as the Miscellaneous Road Traffic Citation
(Amendment) Order, 2017.

2. The Road Traffic (Prohibited Parking) Order is amended in
Part G of the First Schedule by inserting after item 14, the following
items:

“14A. Park Street, between Edward Street and
St. Vincent Street, in the City of Port-of-Spain.

14B. Park Street, between Colville Street and
Phillip Street in the City of Port-of-Spain.”.

3. The Miscellaneous Roads (Unilateral Parking) Order is amended
in Part G of the Schedule by—

(a) Deleting items 8 and 9; and

(b) inserting after item 45, the following items:

“46. Murray Street, Western
b e t w e e n Monday to Saturday
Tragarete Road
and Robert Street

47. Rosalino Street Western”.

4. The Miscellaneous Roads (Unilateral Alternate Parking) Order
is amended in Part G of the Schedule by—

(a) deleting item 29 and substituting the following items:

“29. Park Street, Northern Monday, Wednesday and
Port-of-Spain Friday, Public holidays not
between included
St. Vincent and Southern Tuesday, Thursday and
Charlotte Saturday, Public holidays
Streets not included

- “29A. Park Street, Northern Monday, Wednesday and
Port-of-Spain Friday, Public holidays not
between included
Richmond and Southern Tuesday, Thursday and
Edward Saturday, Public holidays
Streets not included”;

(b) inserting after item 71 the following items:

- “71A. Ariapita Northern Monday to Friday, between
Avenue 6.00 a.m. and 9.00 a.m.
Public holidays not
included
Southern Monday to Friday, between
3.00 p.m. and 6.00 p.m.
Public holidays not
included
- 71B. Alberto Street Eastern Monday, Wednesday, Friday
and Sunday
Western Tuesday, Thursday and
Saturday”;

(c) deleting item 78E and substituting the following item:

- “78E. Murray Western Tuesday, Thursday and
Street, Saturday
between
Robert Street
and Eastern Monday, Wednesday, Friday
Wrightson and Sunday”.

5. The One-Way Traffic Order is amended in Part G of the Schedule by deleting item B 39 and substituting the following item:

- “39. Murray Street, between Robert Street and Adam Smith Square South”.

Traffic routes

6. A person driving a motor vehicle exiting—

- (a) Pole Carew Street onto Tragarete Road shall turn left and continue west along Tragarete Road; and

(b) Kavanagh Street onto Tragarete Road shall turn left and continue east along Tragarete Road.

7. Parking is permitted on Park Street, between Phillip Street and Richmond Street. ^{Parking permitted}

8. Any person who contravenes this Order commits an offence and is liable on summary conviction to a fine not exceeding three thousand ^{Offence and penalty} dollars or to imprisonment for three months.

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in ^{Removal and impounding of vehicles} contravention of this Order may be removed by the Police Service and ^{unlawfully} impounded and dealt with in accordance with section 108(1)(b) of the ^{parked} Motor Vehicles and Road traffic Act.
