ORDER

MADE BY THE MINISTER UNDER SECTION 8A(1) OF THE CUSTOMS ACT

THE COMMON EXTERNAL TARIFF (SUSPENSION)  
ORDER, 2018

1. This Order may be cited as the Common External Tariff <sup>Citation</sup> (Suspension) Order, 2018.

2. In this Order, where “Ex” is used in relation to an item number <sup>Interpretation</sup> under a heading listed in the First Column of the First Schedule to the Customs Act, that item number shall refer only to the corresponding <sup>Chap. 78:01</sup> goods described in the Second Column.

3. The rates of duty set out in the First Schedule to the Customs <sup>Suspension</sup> Act, in relation to the goods carrying the headings and descriptions <sup>of duty in the</sup> listed below in the First and Second Columns respectively, are <sup>First</sup> <sup>Schedule</sup> suspended for the period specified in the Third Column—
