THE CUSTOMS ACT, CHAP. 78:01

REGULATIONS

MADE BY THE PRESIDENT UNDER SECTION 263(1) OF THE CUSTOMS ACT

THE CUSTOMS (FEES) (AMENDMENT) REGULATIONS, 2004

1. These Regulations may be cited as the Customs (Fees) Citation
(Amendment) Regulations, 2004.

2. In these Regulations, “Regulation” or “Regulations” means the G.N. No. 44
Customs (Fees) Regulations, 1957. of 1957

3. Regulation 4(1) is amended—

- (d) in paragraph (d), by deleting the words “\$117.26” and substituting the words “\$136.68”;
- (e) in paragraph (e), by deleting the words “\$117.26” and substituting the words “\$136.68”;
- (f) in paragraph (f), by deleting the words “\$136.79” and substituting the words “\$159.88”;
- (g) in paragraph (g), by deleting the words “\$136.79” and substituting the words “\$159.88”; and
- (h) in paragraph (h), by deleting the words “\$136.79” and “\$68.40” and substituting the words “\$159.88” and “\$79.93” respectively.

4. Regulation 4A is revoked and the following regulation is substituted: Regulation 4A amended

"Overtime fees
Schedule

4A. (1) The overtime fees for duties performed by the officers specified in the Schedule, for any period of time in excess of the hours set out in these Regulations, are payable to the Comptroller at the rates and for the years indicated in the Schedule.

(2) The fees specified in the Schedule in respect of—

(a) the year 2002, are deemed to have come into effect on 1st January, 2002;

(b) the year 2003, are deemed to have come into effect on 1st January, 2003; and

(c) the year 2004, are deemed to have come into effect on 1st January, 2004.

(3) Notwithstanding subregulation (1), any person who utilised any of the services mentioned in the Schedule shall be exempt from the payment of any sums of monies representing the difference between the rates which were payable, in respect of those services, before 1st January, 2002 and the rates set out in the Schedule.".
