REGULATIONS

MADE BY THE MINISTER UNDER SECTION 26(1) OF THE
CITIZENSHIP ACT

THE CITIZENSHIP (AMENDMENT) REGULATIONS, 1988

1. These Regulations may be cited as the Citizenship (Amendment) Regulations, 1988. Citation

2. The Citizenship of the Republic of Trinidad and Tobago Regulations are amended— Chap. 1:50 amended

(a) in regulation 2—

(i) by deleting the words “birth or descent” occurring in line three of subregulation (2); and

(ii) by inserting immediately after subregulation (3) the following—

“ (4) An application for restoration of citizenship made under section 11(2A) of the Act, by a person who ceased to be a citizen of Trinidad and Tobago by birth or descent shall be in the Form set out as Form 15 in the First Schedule.”;

(b) in regulation 3, by inserting immediately after subregulation (3), the following—

“ (4) A person to whom citizenship has been restored shall be granted a Certificate of Restoration of Citizenship in accordance with section 11(2B) of the Act, which certificate shall be set out as Form 16 in the First Schedule.”;

(c) in the First Schedule, by adding immediately after Form 14, the following new Forms—

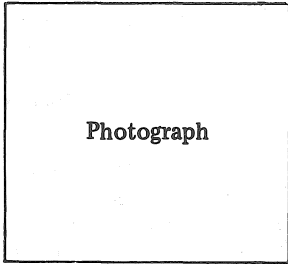
