AN ACT to vary the sums appropriated to Heads of
Expenditure for the Service of Trinidad and Tobago
for the year ending 31st December, 1981.

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Finance (Variation of Short title
Appropriation) (1981) Act, 1982.

Construction

2. In this Act and in any other enactment, a reference to the Appropriation Act, 1981, shall be construed as a reference to that Act as for the time being varied or otherwise amended by any Finance (Variation of Appropriation) Act, passed before this or that other enactment.

3. The sums appropriated to the several Heads of Expenditure set out in the first column of Part I of the Schedule by the Appropriation Act, 1981, are hereby increased by the amounts specified in the second column of the said Part I.

Reduction
in Head of
Expenditure

4. The sum appropriated to the Head of Expenditure set out in the first column of Part II of the Schedule by the Appropriation Act, 1981 is hereby reduced by the amount specified in the second column of the said Part II.

5. Notwithstanding anything contained in the Exchequer and Audit Act, Chap. 69:01, the sum appropriated in respect of the Head of Expenditure set out in the first column of Part II of the Schedule by the Appropriation Act, 1981 and unissued at the commencement of this Act, may be utilised for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure set out in the first column of Part I of the Schedule.
