AN ORDINANCE for making Supplementary Appropriation for the Public Services of Trinidad and Tobago for the year ended on the 31st December, 1958.

Commencement.

ENACTED by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof. Enactment.

1. This Ordinance may be cited as the 1958 Supplementary Appropriation Ordinance, 1960. Short title.

The further sum of seven million, seventy-seven thousand, and fifty-six dollars and eighty-nine cents shall be charged upon the Revenue and other Funds of the Territory for certain public services for the year ended on the 31st day of December, 1958, to be appropriated as set out in the Schedule hereto.

3. The further sum of four hundred and fifteen thousand, six hundred and ninety dollars and thirty-six cents shall be charged upon the Revenue and other Funds of the Port Services Department for certain public services for the year ended on the 31st day of December, 1958.

4. The further sum of thirty-nine thousand, three hundred and ninety dollars and seventy-two cents shall be charged upon the Revenue and other Funds of the Railway Department for certain public services for the year ended on the 31st day of December, 1958.
