Act No. 24 of 1964

AN ACT to provide for Supplementary Appropriation for the service of Trinidad and Tobago for the year ending on the 31st day of December, 1964.

[Assented to 17th December, 1964]

BE IT ENACTED by The Queen's Most Excellent Majesty, by ^{Enactment} and with the advice and consent of the Senate and House of Representatives of Trinidad and Tobago, and by the authority of the same, as follows :—

1. This Act may be cited as the Fourth Supplementary ^{Short title} Appropriation Act, 1964.

2. A further issue from the Consolidated Fund of the sum of twenty-seven million, four hundred and sixty-seven thousand, eight hundred and twenty-one dollars is hereby authorised for meeting expenditure for the service of the year ending 31st December, 1964 under the Heads of expenditure specified in the Schedule; and the sum specified in the said Schedule opposite to a Head is hereby appropriated out of the said sum of twenty-seven million, four hundred and sixty-seven thousand eight hundred and twenty-one dollars for the purposes specified in relation to that Head in the Estimates for the said year.
