AN ORDINANCE to amend the Produce Taxation Ordinance, 1921.

[1st January, 1922.]

BE it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

1. The tax payable on molasses under the Produce Taxation Ordinance, 1921, shall be at the rate of seven pence for every one hundred gallons, and the schedule to the said Ordinance shall be deemed to be amended accordingly. Short title

2. This Ordinance shall be deemed to have commenced and come into operation on the 1st day of January, 1922. Commence-
ment.
