AN ORDINANCE for taking the Census of the Colony for the year 1921.

[31st May, 1920.]

WHEREAS it is expedient to take the Census of this Colony in the year One thousand Nine hundred and twenty-one: Be it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

1. The Governor shall cause to be prepared and printed for the use of the persons to be employed in taking the Census such forms and instructions as he deems necessary; and all such forms and instructions shall be issued to the persons for whose use they are intended, and all the expenses which are incurred by the authority of the Governor under this Ordinance shall be paid out of the public revenue of the Colony.

2. The Governor shall form the City of Port-of-Spain and the Boroughs of San Fernando and Arima and each

County in this Colony, including in every such County any town situate within the limits of such County into several enumeration districts for the purposes of this Ordinance, and shall appoint such persons as he sees fit as Enumerators for each of such districts, and shall assign a particular portion of such districts to each of such Enumerators.

**Schedules.**

3. Schedules shall be prepared by or under the direction of the Governor for the purpose of being filled up, by or on behalf of the several occupiers of plantations and dwelling-houses, as hereinafter provided, with particulars of the name, sex, age, rank, profession or occupation, degree of education, condition, birthplace and religious persuasion of every living person who abode in or upon every plantation or house on the night of a day in the month of April, one thousand nine hundred and twenty-one, to be fixed by the Governor by Proclamation, and also whether any were blind, or deaf and dumb, mentally deranged, or lepers, and with particulars of all live stock on such plantations or premises; and the Enumerators under this Ordinance shall in the course of the week ending on the day so fixed by the Governor, leave or cause to be left at every plantation and at every dwelling-house not being upon a plantation within their respective sub-districts, one or more of the said schedules for the managers of such plantations and the occupier or occupiers of such dwelling-house or of any part thereof; and upon every such schedule shall be plainly expressed that it is to be filled up by the manager of such plantation and the occupier of such dwelling-house and, where such dwelling-house is let in different stories or apartments and occupied distinctly by different persons or families, by the occupier of each such distinct story or apartment, and that the Enumerator will collect all such schedules within his sub-district on the day then next following the day so fixed by the Governor.

4. The owner, manager or other person having the superintendence of and residing upon any plantation, shall act as Enumerator of such plantation.

**Persons re-

5. Every person for the time being having the superintendence of and residing upon any plantation, and every occupier of any dwelling-house or of any distinct story or apartment in any dwelling-house, with or for whom any

such schedule is left as aforesaid, shall fill up the said schedule to the best of his knowledge and belief, so far as relates to all persons dwelling upon such plantation or in the house, story or apartment occupied by him, and so far as relates to such live stock as aforesaid, and shall sign his name thereunto, and shall deliver the schedule so filled up or cause the same to be delivered to the Enumerator when required so to do; and every such person having the superintendence of a plantation, and every such occupier who wilfully refuses or without lawful excuse neglects to fill up the said schedule to the best of his knowledge and belief or to sign and deliver the same as herein required, or who wilfully makes, signs or delivers, or causes to be made, signed or delivered, any false return of all or any of the matters specified in the said schedule, shall forfeit a sum not exceeding five pounds.

6. The Enumerators shall visit every plantation or house in their respective sub-districts, and shall collect all the schedules so left within their sub-districts so far as may be possible on a day in the month of April, one thousand nine hundred and twenty-one, to be fixed by the Governor by Proclamation, and shall complete such of the schedules as upon delivery thereof to them appear to be defective, and correct such as they find to be erroneous, and shall add a schedule containing an account according to the best information which they are able to obtain of all the other persons living within their sub-district who are not included in the schedules so collected by them, and shall abstract, copy or otherwise deal with such schedules and generally act for the purpose of carrying out this section as directed by the Governor.

7. Every enumerator shall take an account of the occupied houses and of the houses in course of erection and uninhabited and of all other uninhabited houses within his sub-district, and shall also take an account of all such particulars hereinbefore mentioned and none other as by the forms and instructions which may be issued under this Ordinance he may be directed to inquire into, and shall deliver the schedules collected by him to the Superintendent-Registrar of the City of Port-of-Spain where the enumeration sub-district is within the City of Port-of-

Spain, or to the Superintendent-Registrar of the Borough of San Fernando where the enumeration district is within the Borough of San Fernando, or to the Superintendent-Registrar of the Borough of Arima where the enumeration district is within the Borough of Arima, and to the Warden of the County where the enumeration district is within any Ward, and shall sign a form of declaration to the effect that the said schedules have been truly and faithfully collected, and where necessary completed and corrected by him, and that to the best of his knowledge the same are complete and correct so far as may be known; which form of declaration shall be prepared under the direction of the Governor, and issued with the forms and instructions aforesaid.

Return of

8. The Superintendent-Registrar or the Warden to whom such schedules are delivered shall examine the same, and satisfy himself whether the instructions in each case have been punctually fulfilled, and if not, shall cause any defect or inaccuracy to be supplied, so far as is practicable, and when the schedules have been made as accurate as is practicable, the Superintendent-Registrar or the Warden shall on or before a day in the month of May, one thousand nine hundred and twenty-one, to be fixed by the Governor by Proclamation, return all the schedules which have been delivered to him to the Registrar-General.

Abstract of  
returns.

9. The Governor shall cause an abstract to be made of the said returns, and such abstract shall be printed and laid before the Legislative Council as soon as conveniently may be and not later than the first meeting of the said Council in the year one thousand nine hundred and twenty-three.

Enumerators  
of Gaols, &c.

10. The keeper or person in charge of every gaol, prison, lockup-house, reformatory, hospital or asylum, shall act as Enumerator of the inmates thereof.

Returns of  
houseless  
persons.

11. The Governor shall obtain by such ways and means as appear to him best adapted for the purpose, returns of the particulars required by this Ordinance with respect to all houseless persons and all persons who during the night of the day fixed by the Governor under section three hereof were travelling or on shipboard or for any other

reason were not abiding in any house of which account is to be taken by the Enumerators and other persons as aforesaid, and shall include such returns in the abstract to be made by him as aforesaid.

12. The Governor shall cause to be prepared a table of Allowances. allowances to be made to the several Enumerators, Superintendent-Registrars, Wardens and other persons employed in the execution of this Ordinance, and such table shall be laid before the Legislative Council on or before the first meeting of Council in the year one thousand nine hundred and twenty-one.

13. There shall be paid out of the public funds of the Colony, under the warrant of the Governor, the whole amount of the allowances to which the Superintendent-Registrars, Wardens, Enumerators and other persons in each district, are severally entitled according to the said table: Provided always that no such payment shall be made to any Enumerator or other person required to act as an Enumerator under this Ordinance except upon production of a certificate under the hand of the Superintendent-Registrar of the city of Port-of-Spain, where the enumeration district is within the city of Port-of-Spain, or of the Superintendent-Registrar of the Borough of San Fernando where the enumeration district is within the Borough of San Fernando, or of the Superintendent-Registrar of the Borough of Arima where the enumeration district is within the Borough of Arima, or of the Warden of the county where the enumeration district is within any ward, certifying that the duties required of such Enumerator or other person have been faithfully performed, and the like certificate under the hand of the Registrar-General with respect to the Superintendent-Registrars and Wardens before any payment is made to such Superintendent-Registrars or Wardens. Payment of Allowances.

14. Every Superintendent-Registrar and Warden and every Enumerator and other person required to act as Enumerator making wilful default in any of the matters required of him by this Ordinance, or making any wilfully false declaration, shall for every such wilful default or wilfully false declaration forfeit a sum not exceeding five pounds. Offences by persons employed under Ordinance.

Failure to  
answer ques-  
tions truly.

15. The Governor shall cause instructions to be prepared containing such questions as he deems proper to be put in order to give effect to this Ordinance, and the Enumerators or other persons employed in the execution of this Ordinance shall be authorized to ask all such questions, and every person refusing to answer or wilfully giving a false answer to such questions or any of them, and every person wilfully obstructing any Enumerator or other person employed in the execution of this Ordinance, shall, for every such refusal or wilfully false answer or wilful obstruction, forfeit a sum not exceeding five pounds.

Procedure.

16. All penalties imposed by this Ordinance may be recovered in a summary manner by any person authorized in writing by the Registrar-General or by the Warden of any county before any Magistrate, and the procedure shall be according to the Summary Conviction Offences (Procedure) Ordinance, 1918, or any Ordinance amending the same.
