AN ORDINANCE to make provision for defraying the expenses of the Government of the Colony of Trinidad and Tobago for the year 1946.

ENACTED by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof. Enactment.

1. This Ordinance may be cited as the Appropriation Ordinance, 1946, and shall be deemed to have come into force on the 1st January, 1946. Short title and commencement.
