ENACTED by the Governor of Trinidad and Tobago with the Enactmen

1. This Ordinance may be cited as the Arima Corporation Short title.
(Amendment) Ordinance, 1946, and shall be read as one with
the Arima Corporation Ordinance, hereinafter referred to as Ch. 39. No. 11.

2. Paragraph (a) of subsection (2) of section 8 of the Principal Ordinance is hereby amended by the deletion therefrom of the words "at an annual rateable value of not less than forty-eight dollars" and of the words "at an annual rateable value of not less than thirty-six dollars" appearing therein.

3. Subsection (1) of section 12 of the Principal Ordinance is hereby amended as follows—

(a) by the substitution of the word "forty-eight" for the word "ninety-six" and of the word "seventy-two" for the words "one hundred and twenty" appearing in paragraph (c) thereof; and

(b) by the substitution of the words "four hundred and eighty" for the words "seven hundred and twenty" appearing in paragraph (d) thereof.

4. Subsection (2) of section 12 of the Principal Ordinance is hereby amended by the substitution of the following paragraph for paragraph (c) thereof—

"(c) if and while he is the holder of an office of emolument under the Crown or under the Government of the Colony; or".

5. Form D in the Fourth Schedule to the Principal Ordinance is hereby amended as follows—

(a) by the deletion of the words and symbol "at the annual rateable value of \$" from paragraph (a) thereof; and

(b) by the deletion of the word and symbol "at \$" from paragraph (b) thereof; and

(c) by the deletion of the words and symbol "at an annual rateable value of \$" from paragraph (c) thereof.

Amendment
of Form F in
4th Schedule
to Principal
Ordinance.

6. Form F in the Fourth Schedule to the Principal Ordinance is hereby amended by the deletion from the column headed "Nature of qualification" of the first paragraph and by the substitution therefor of the following paragraph—

"Occupier of house (or part of a house for which he has paid not less than one year's rent amounting to \$)".
