Appropriation.

AN ORDINANCE to make provision for defraying the expenses of the Government of the Colony of Trinidad and Tobago for the year 1942.

[1st January, 1942]

Commencement.

1. This Ordinance may be cited as the Appropriation Ordinance, 1941. Short title.

2. There may be issued and paid from and out of the Public Moneys of the Colony of Trinidad and Tobago for the service of the year 1942, an amount not exceeding the following sums, that is to say:— Providing for payment from public funds.
