AN ORDINANCE to make provision for defraying the expenses of the Government of the Colony of Trinidad and Tobago for the year 1941.

Commencement.

[1st January, 1941]

ENACTED by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof.

Short title.

1. This Ordinance may be cited as the Appropriation Ordinance, 1940, and shall come into operation on the 1st January, 1941.

2. There may be issued and paid from and out of the Public Moneys of the Colony of Trinidad and Tobago for the service of the year 1941, an amount not exceeding the following sums, that is to say:—
