AN ORDINANCE to make provision for defraying the Expenses of the Government of the Colony of Trinidad and Tobago for the year 1935.

BE it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

Short title.

1. This Ordinance may be cited as the Appropriation Ordinance, 1934, and shall come into operation on the 1st day of January, 1935.
