AN ORDINANCE to make provision for defraying the Expenses of the Government of the Colony of Trinidad and Tobago for the year 1936.

**B**E it enacted by the Governor of Trinidad and Tobago with the advice and consent of the Legislative Council thereof as follows:—

1. This Ordinance may be cited as the Appropriation Ordinance, 1935, and shall come into operation on the 1st day of January, 1936.
