REPUBLIC OF TRINIDAD AND TOBAGO

**Act No. 19 of 1995**

AN ACT for the Incorporation of the Trinidad and  
Tobago Secondary Schools Football League and for  
matters incidental thereto.

*[Assented to 22nd August, 1995]*

WHEREAS there has been established in Trinidad and Tobago, an Organisation known as the Trinidad and Tobago Secondary Schools Football League: Preamble

And whereas it is expedient that the Trinidad and Tobago Secondary Schools Football League be incorporated for the purposes hereinafter set forth:

Enactment	ENACTED by the Parliament of Trinidad and Tobago as follows:
Short title	1. This Act may be cited as the Trinidad and Tobago Secondary Schools Football League (Incorporation) Act, 1995.
Incorporation	2. The Trinidad and Tobago Secondary Schools Football League (hereinafter called "the Organisation") is hereby created a body corporate.
Aims and objects	3. The aims and objects of the Organisation are— (a) to encourage and promote the sport of football among the members of the Organisation; (b) to instill in the players a true respect for law and authority and to foster the spirit of sportsmanship; and (c) to do all such other things as are necessary or conducive to the attainment of the above-mentioned objects.
Powers of the Organisation	4. The Organisation shall have power— (a) to acquire by purchase, transfer, donation, exchange, devise, bequest, grant, gift, conveyance or howsoever otherwise any real or personal property or any estate or interest therein; (b) to accept surrenders or reconveyances and to enter into contracts; and (c) to sell, exchange, demise, mortgage or otherwise dispose of and deal with all property which may for the time being be vested in it subject to any restraint, reservation or condition contained in the document under which it has acquired title.

5. All real or personal property of whatever nature Transfer and vesting  
of property now held by or vested in, any person for the use and benefit of the Organisation is hereby transferred to and vested in the Organisation.

6. All documents requiring the seal of the Mode of execution of  
documents Organisation shall be sealed with the common seal of the Organisation in the presence of the President and Secretary for the time being in office, or in the event of incapacity in the presence of some other person or persons authorised for that purpose by the Organisation, who shall both sign every such document and such signing shall be *prima facie* evidence that the said seal was duly affixed and that the same is the lawful seal of the Organisation.

7. (1) The Organisation shall at all times have a Service of documents fixed address in Trinidad and Tobago for the service of documents on it and that address and any change thereof, shall be registered with the Registrar General within twenty-eight days of the date of incorporation or the change of address as the case may be.

(2) Every document to be served to the Organisation, may be served by leaving the same at, or by sending the same by registered post to the registered address of the Organisation.

(3) Failure to register the address and any change thereof, is a summary offence and renders the Organisation liable to a fine of one hundred and twenty dollars and to a further fine of ten dollars for each day during which the offence continues after conviction therefor.

8. The Organisation may, from time to time, make Power to make rules rules for the proper conduct of its proceedings and discharge of its duties, powers and functions.

Saving of State and  
other rights

9. Nothing in this Act shall affect or be deemed to affect the rights of the State, or of any bodies politic or corporate or of any persons, except such as are mentioned or referred to in this Act and those claiming by, through, from or under them.
