Act No. 44 of 1997

[L.S.]

AN ACT to supplement and vary the appropriation of the sum, the issue of which was authorised by the Appropriation Act, 1997.

[Assented to 12th December, 1997]

ENACTED by the Parliament of Trinidad and Tobago as Enactment follows:—

1. This Act may be cited as the Finance Short title (Supplementation and Variation of Appropriation) (1997) (No. 2) Act, 1997.

Construction of Act

2. In this Act and in any other written law, a reference to the Appropriation Act, 1997, shall be construed as a reference to that Act as for the time being varied or otherwise amended by the Finance (Supplementation and Variation of the Appropriation) (1997) Act, 1997, and by any Finance (Variation of Appropriation) Act, passed before this or that other written law.

Further issue of

3. A further issue from the Consolidated Fund of the sum of five hundred and twenty-one million, seven hundred and ten thousand, seven hundred dollars is authorized for meeting expenditure for the service of the year ending 31st December, 1997, and appropriated in respect of the following Heads indicated in the Schedule to the Appropriation Act, 1997, entitled:

15—Tobago House of Assembly

18—Ministry of Finance

Increase of Heads of

4. The sums appropriated to the several Heads of Expenditure set out in the First Column of Part I of the Schedule by the Appropriation Act, 1997, are increased by the amounts specified in the Second Column of that Part.

Reduction in Heads
of Expenditure

5. The sums appropriated to the several Heads of Expenditure set out in the First Column of Part II of the Schedule by the Appropriation Act, 1997, are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated
in respect of Heads
in Part II may be
utilised

6. Notwithstanding anything contained in the Exchequer and Audit Act, the sums appropriated in respect of the Heads of Expenditure set out in the First Column of Part II of the Schedule by the Appropriation Act, 1997, and unissued at the commencement of this Act, may be utilised for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Heads of Expenditure set out in Part I of the Schedule.
