Act No. 4 of 2000

AN ACT to vary the appropriation of the sum of the
issue of which was authorized by the Appropriation
Act, 1998/1999.

[Assented to 31st January, 2000]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Finance (Variation of Short title
Appropriation) (1998/1999) Act, 2000.

Construction of
Act No. 34 of 1998

2. In this Act and in any other written law, a reference to the Appropriation Act, 1998/1999 shall be construed as a reference to that Act as for the time being varied or otherwise amended by any Finance (Variation of Appropriation) Act, passed before this or that other written law.

Increase in Head of
Expenditure—
Schedule

3. The sum appropriated to the Head of Expenditure set out in the First Column of Part I of the Schedule to this Act by the Appropriation Act, 1998/1999 is hereby increased by the amount specified in the Second Column of that Part.

Reduction in Heads
of Expenditure

4. The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 1998/1999 are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated
in respect of Heads
specified in Part II
may be utilised
Chap. 69:01

5. The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to this Act by the Appropriation Act, 1998/1999 and unissued at the commencement of this Act but not exceeding the amount specified as reduced in the Second Column of Part II of the Schedule to this Act may be utilised, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in the expenditure in respect of the Head of Expenditure specified in Part I of the Schedule.
