REPUBLIC OF TRINIDAD AND TOBAGO

**Act No. 30 of 2000**

AN ACT to supplement and vary the appropriation of the  
sum of the issue of which was authorized by the  
Appropriation Act, 1999/2000.

*[Assented to 15th June, 2000]*

ENACTED by the Parliament of Trinidad and Tobago as Enactment  
follows:—

**1.** This Act may be cited as the Short title  
**(Supplementation and Variation of Appropriation)**  
**(1999/2000) Act, 2000.**

Further issue from  
the Consolidated  
Fund

**2.** A further issue from the Consolidated Fund in the sum of nine hundred and twenty-seven million, six hundred and fifty-one thousand, five hundred and nineteen dollars is authorized for meeting expenditure for the service of the financial year ending September 30, 2000 and appropriated in respect of the following Head in the Schedule to the Appropriation Act, 1999/2000 entitled:

19—CHARGES ON ACCOUNT OF THE PUBLIC DEBT

Increase in Heads of  
Expenditure—  
Schedule

**3.** The sums appropriated to the Heads of Expenditure specified in the First Column of Part I of the Schedule by the Appropriation Act, 1999/2000 are increased by the amounts specified in the Second Column of that Part.

Reduction in Heads  
of Expenditure—  
Schedule

**4.** The sums appropriated to the Heads of Expenditure specified in the First Column of Part II of the Schedule by the Appropriation Act, 1999/2000 are reduced by the amounts specified in the Second Column of that Part.

Sums appropriated  
in respect of Heads  
specified in Part II  
may be utilized  
Act No. 30 of 1999

**5.** The sums appropriated in respect of the Heads of Expenditure specified in the First Column of Part II of the Schedule to the Appropriation Act, 1999/2000 and not utilized at the commencement of this Act and not exceeding the amount specified as reduced in the Second Column of Part II of the Schedule may be utilized, notwithstanding anything contained in the Exchequer and Audit Act, for the discharge of any liability incurred by reason of the increase in expenditure in respect of the Heads of Expenditure specified in Part I of the Schedule.
