REGULATIONS

MADE BY THE PRESIDENT UNDER SECTION 263(1) OF THE CUSTOMS ACT

THE CUSTOMS (FEES) (AMENDMENT) REGULATIONS, 2014

1. These Regulations may be cited as the Customs (Fees) Citation
(Amendment) Regulations, 2014.

“Overtime fees” 4A. (1) The overtime fees for duties performed by the officers specified in the Schedule, for any period of time in excess of the hours set out in these Regulations, are payable to the Comptroller at the rates and for the years indicated in the Schedule.

Schedule

- (2) The fees specified in the Schedule in respect of—
 - (a) the year 2008, are deemed to have come into effect on 1st January, 2008;
 - (b) the year 2009, are deemed to have come into effect on 1st January, 2009;
 - (c) the year 2010, are deemed to have come into effect on 1st January, 2010; and
 - (d) the year 2011, are deemed to have come into effect on 1st January, 2011.

(3) Notwithstanding subregulation (1), any person who utilized any of the services mentioned in the Schedule shall be exempt from the payment of any sums of monies representing the difference between the rates which were payable, in respect of those services, before 1st January, 2008 and the rates set out in the Schedule.”.
