ORDER

MADE BY THE PRESIDENT UNDER SECTION 189(1) OF THE DEFENCE ACT

THE DEFENCE (JOINT COMBINED EXCHANGE TRAINING
AND JUNGLE WARFARE EXERCISES) (REQUISITION
OF LANDS) (NO. 3) ORDER, 2002

1. This Order may be cited as the Defence (Joint Combined Exchange Training and Jungle Warfare Exercises) (Requisition of Lands) (No. 3) Order, 2002. ^{Citation}

2. The lands described in the Schedule are requisitioned for the period 31st May, 2002 to 14th June, 2002, for the purpose of the training, exercises and manoeuvres of the Trinidad and Tobago Defence Force in pursuance of the reciprocal training exercises between the French Forces of the Antilles and the Trinidad and Tobago Defence Force scheduled to take place from 31st May, 2002 to 14th June, 2002. ^{Requisition of lands Schedule}

SCHEDULE

(Paragraph 2)

The requisitioned area shall comprise State lands within the following boundaries:

On the north by a line commencing from the Chacachacare Lighthouse (061° 45' 24" Longitude, 10° 41' 30" Latitude) and running in an east north-easterly direction to Corozal Point (061° 37' Longitude, 10° 44' 42" Latitude) and running in an east south-easterly direction to Morne Jean (061° 35' 10" Longitude, 10° 43' 45" Latitude);

On the east by a line commencing from Morne Jean (061° 35' 10" Longitude, 10° 43' 45" Latitude) and running in a southerly direction to Nelson Island (061° 36' 25" Longitude, 10° 39' 30" Latitude);

On the south by a line commencing from Nelson Island (061° 36' 25" Longitude, 10° 39' 30" Latitude) and running in a west north-westerly direction to Diamond Rock (061° 46' 24" Longitude, 10° 40' Latitude); and

On the west by a line commencing from Diamond Rock (061° 46' 24" Longitude, 10° 41' 40" Latitude) and running in a north-easterly direction to the Chacachacare Lighthouse (061° 45' 24" Longitude, 10° 41' 30" Latitude).
