



TRINIDAD AND TOBAGO

**Act No. 6 of 1970**

[L.S.]

AN ACT to amend the Education Act, 1966 and to make consequential or incidental amendments to the Civil Service Act, 1965.

*[Assented to 27th February, 1970]*

BE IT ENACTED by the Queen's Most Excellent Majesty, <sup>Enactment</sup> by and with the advice and consent of the Senate and House of Representatives of Trinidad and Tobago, and by the authority of the same, as follows:—

1. This Act may be cited as the Education (Amendment) <sup>Short title</sup> Act, 1970.

Section 53 of

2. Section 53(1) of the Education Act, 1966 (hereinafter referred to as "the Act") is repealed and replaced as follows:—

53. (1) For the purposes of the school system established by section 12, there is hereby established a unified Teaching Service, which shall comprise—

(a) all teachers appointed before the commencement of the Trinidad and Tobago Constitution (Amendment) Act, 1968;

(b) all teachers deemed under section 54(1) to be appointed members of the Teaching Service;

(c) all teachers appointed by the Teaching Service Commission after the commencement of the Act referred to in paragraph (a);

(d) persons who are holders of any administrative office set out in Division I of the First Schedule,

and such Teaching Service shall, subject to this Act, be classified in accordance with the Classification Offices set out in the First Schedule."

3. Section 54(3) of the Act is repealed.

New section 54A  
provided for

4. The Act is amended by inserting immediately after section 54 thereof the following new section—

"Terms and  
conditions  
of certain  
persons

54A. Notwithstanding anything to the contrary in this Part, but subject to sections 99A to 99C of the Constitution—

(a) the terms and conditions applicable to civil servants under the Civil Service Act, 1965, and any regulations made thereunder shall apply to persons referred to in section 53(1)(d);

(b) section 24 of the Civil Service Act, 1965 shall apply as if the holders of the several posts referred to in section 53(1)(d) held public

office in the public service that by section 3(1) of the Civil Service Act, 1965 is deemed to be an office in the Civil Service.”.

5. The First Schedule to the Act is repealed and replaced by the First Schedule set out in Schedule I hereto. First Schedule of Act repealed and replaced
