MADE BY THE PRESIDENT UNDER SECTION 8 OF THE CUSTOMS ACT

THE CUSTOMS (COMMON EXTERNAL TARIFF) (No. 2 )  
ORDER, 2004

1. This Order may be cited as the Customs (Common External Citation  
Tariff) (No. 2) Order, 2004.

2. The Common External Tariff set out in the First Schedule to the  
Customs Act is amended in the manner detailed below—

(a) by deleting the Heading 4802.56.00 with the corresponding  
Description of Goods and Rate of Duty;

(b) by inserting immediately after Heading 4802.55.00  
the following Headings, Descriptions of Goods and  
Rates of Duty in the First, Second and Third Columns  
respectively:

<i>Heading</i>	<i>Description of Goods</i>	<i>Rate of Duty</i>
"4802.56.00	Weighing 40g/m <sup>2</sup> or more but not more than 150g/m <sup>2</sup> in sheets with one side not exceeding 435 mm and the other side not exceeding 297 mm in the unfolded state:	
4802.56.10	Other Paper and Paperboard of a kind used for writing, printing or other graphic purposes ... ..	20%
4802.56.90	Other ... ..	Free".

(c) by deleting the Heading 4802.62.00 with the corresponding  
Description of Goods and Rate of Duty;

(d) by inserting immediately after Heading 4802.61.00 the following Headings, Descriptions of Goods and Rates of Duty in the First, Second and Third Columns respectively:

First Column <i>Heading</i>	Second Column <i>Description of Goods</i>	Third Column <i>Rate of Duty</i>
"4802.62.00	In sheets with one side not exceeding 435 mm and the other side not exceeding 297 mm in the unfolded state:	
4802.62.10	Other Paper and Paperboard of a kind used for writing, printing or other graphic purposes: ... ..	20%
4802.62.90	Other ... ..	Free".

(e) by inserting immediately after Heading 4823.90.20 the following Heading, Description of Goods and Rate of Duty in the First, Second and Third Columns respectively:

First Column <i>Heading</i>	Second Column <i>Description of Goods</i>	Third Column <i>Rate of Duty</i>
"4823.90.30	Other Paper and Paperboard of a kind used for writing, printing or other graphic purposes: ... ..	20%".

(f) by deleting Heading 7010.90.00 with the corresponding Description of Goods and Rate of Duty;

(g) by inserting immediately after Heading 7010.20.00 the following Headings, Descriptions of Goods and Rates of Duty in the First, Second and Third Columns respectively:

First Column <i>Heading</i>	Second Column <i>Description of Goods</i>	Third Column <i>Rate of Duty</i>
"7010.90.00	Other:	
7010.90.10	Bottles for Soft Drinks, Beer, Wines and Spirits: ... ..	15%
7010.90.90	Other ... ..	5%".
