THE EMERGENCY POWERS REGULATIONS, 2026

ORDER

MADE BY THE MINISTER OF HOMELAND SECURITY IN ACCORDANCE  
WITH PARAGRAPH 2 OF THE SCHEDULE TO THE EMERGENCY POWERS  
REGULATIONS, 2026

DETENTION ORDER

WHEREAS it is enacted by regulation 14 of the Emergency Powers Regulations, 2026, that the provisions of the Schedule shall have effect for the purpose of the preventive detention of persons:

And whereas it is provided in paragraph 2 of the Schedule of the Emergency Powers Regulations, 2026, that the Minister may, if satisfied with respect to any person that, with a view to preventing him from acting in any manner prejudicial to public safety and that it is necessary to provide for his preventive detention, make an order that he be detained and stating concisely the grounds for such detention:

And whereas it is further provided in paragraph 3(1) of the Schedule of the Emergency Powers Regulations, 2026, that any person in respect of whom a detention order is in force may be arrested without warrant by any police officer and may be detained in such place and under such conditions as the Minister may from time to time direct:

And whereas I, the Honourable Roger Alexander, Minister of Homeland Security, am satisfied with respect to ELIJAH OTTWAY also known as “FLAPPY” of 3, Eccles Street, Bon Air North East, Windy Hill, Arouca, that it is necessary to provide for his preventive detention with a view to preventing him from acting in a manner prejudicial to public safety:

Now, therefore, I, the Honourable Roger Alexander, Minister of Homeland Security, in exercise of the powers conferred upon me, do hereby order that the said ELIJAH OTTWAY also known as “FLAPPY” of 3, Eccles Street, Bon Air North East, Windy Hill, Arouca, shall be

detained at the Eastern Correctional Rehabilitation Centre located at Santa Rosa, Arima, or such other place as I may from time to time direct as the place where the said ELIJAH OTTWAY also known as “FLAPPY” of 3, Eccles Street, Bon Air North East, Windy Hill, Arouca, shall be detained and so kept in lawful custody.

TAKE NOTICE that the grounds upon which this detention order is made are as follows:

The detainee, ELIJAH OTTWAY also known as “FLAPPY” has been credibly identified as a member and tactical shooter within an organised criminal network, comprising a coalition between the “Sixx” Organised Crime Group and the “Windy Hill Radical Islamic” Organised Crime Group, both of which fall within the definition of an Organised Crime Group (‘OCG’) under the Anti-Gang Act, 2021. The OCGs have confirmed access to a cache of firearms and ammunition. He is a weapons custodian and manages weapon stashes within the Windy Hill district. Confidential intelligence directly links the detainee as one of the primary shooters in a recent targeted homicide which resulted in one death and three injured persons as part of an on-going gang conflict. The detainee and others intend to imminently carry out further reprisal attacks on gang rivals in public spaces using firearms. The detainee’s residence has been utilised as a meeting location for the dissemination of instructions to execute rival gang members.

A Preventive Detention Order pursuant to regulation 14 of the Emergency Powers Regulations, 2026, is necessary to disrupt these plans and prevent him from acting in a manner prejudicial to public safety.
