ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(PAN-AROUND-THE-NECK PRELIMINARIES) ORDER, 1994

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Pan-around-the-neck Preliminaries) Order, 1994.

2. This Order has effect between the hours of 6.00 p.m. on Friday, 28th January, 1994 and 3.00 a.m. on Saturday, 29th January, 1994.

3. Parking is prohibited on the following roads:

Parking
prohibited

- (a) Independence Square North, between Wrightson Road and Charlotte Street;
- (b) Henry Street, between Independence Square South and Queen Street;
- (c) Queen Street, between Charlotte Street and St. Vincent Street;
- (d) St. Vincent Street, between Sackville Street and South Quay;
- (e) Abercromby Street, between Independence Square South and South Quay;
- (f) Charlotte Street, between Prince Street and Independence Square North;
- (g) Prince Street, between Frederick Street and Charlotte Street;
- (h) on the eastern side of Chacon Street, between Independence Square South and South Quay.

4. Notwithstanding paragraph 3(d), vehicles conveying Steel Pans may park on St. Vincent Street, between Independence Square South and South Quay.

restricted

5. Vehicular traffic is prohibited on the following roads:

Roads closed

- (a) Queen Street, between Charlotte Street and St. Vincent Street;

- (b) Henry Street, between Prince Street and Independence Square South;
- (c) St. Vincent Street, between Hart Street and Independence Square South;
- (d) Independence Square North, between Richmond Street and Charlotte Street;
- (e) Abercromby Street, between Independence Square North and Independence Square South;
- (f) Broadway, between Independence Square South and South Quay;
- (g) Richmond Street, between London Street and Independence Square North;
- (h) Henry Street, between Independence Square South and South Quay; except for Tunapuna, Sangre Grande and Arima taxis plying for hire in that area.

Alternative routes

6. Vehicular traffic shall proceed as follows:

- (a) vehicles proceeding South along Frederick Street shall turn East into Prince Street, except taxis plying for hire on Hart Street;
- (b) vehicles proceeding East along Wrightson Road shall not enter Independence Square North;
- (c) vehicles proceeding South along Richmond Street shall turn right at London Street;
- (d) vehicles proceeding West along Independence Square South shall turn South into Charlotte Street.

Vehicular traffic

7. Vehicular traffic shall proceed in a southerly direction only on Charlotte Street, between South Quay and Independence Square South.

Taxi stands

8. Taxis shall operate as follows:

- (a) maxi-taxis plying for hire on the Diego Martin and Petit Valley routes shall ply for hire on the southern side of South Quay, from a point five metres West of Broadway to a point five metres East of St. Vincent Street;
- (b) Diego Martin and Petit Valley taxis plying for hire from the southern side of Independence Square North, between Abercromby Street and Chacon Street, shall ply for hire on the northern side of Independence Square South, from a point five metres West of Abercromby Street to a point five metres East of St. Vincent Street, in a westerly direction;

- (c) Long Circular and Wrightson Road taxis plying for hire from the southern side of Independence Square North, between Chacon Street and Cipriani Circle, shall ply for hire on the eastern side of Abercromby Street, from a point five metres North of South Quay to a point five metres South of Independence Square South, in a northerly direction;
- (d) San Fernando/Chaguanas taxis plying for hire from the northern side of Independence Square North, between Charlotte Street and Henry Street, shall ply for hire on the southern side of Independence Square North, from a point five metres East of Charlotte Street to a point five metres West of George Street;
- (e) La Horquetta/Sangre Grande maxi-taxis plying for hire on Broadway, between South Quay and Independence Square South, shall ply for hire on the northern side of the northern carriageway of Beetham Highway from a point five metres East of Broadway and continuing;
- (f) Arima/Maloney maxi-taxis plying for hire on Broadway, between South Quay and Independence Square South, shall ply for hire on the northern side of the northern carriageway of Beetham Highway from a point five metres West of Broadway and continuing;
- (g) maxi-taxis plying for hire on Charlotte Street, between Independence Square South and South Quay shall ply for hire on the northern side of South Quay from a point five metres East of Nelson Street to a point five metres West of Piccadilly Street.

9. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
