THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(CARNIVAL) ORDER, 1994

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Carnival) Order, 1994. Citation

2. Notwithstanding any enactment to the contrary, motorists attending the Parade of Bands at the Grand Stand may park their vehicles on the Queen's Park Savannah, during the period commencing three hours before the start of the function and ending three hours after the closure of the function. Parking of vehicles on Queen's Park Savannah

PART I

PORT-OF-SPAIN

3. On Monday, 14th February, 1994, parking is prohibited on the undermentioned roads and all roads lying within and bounded by the said undermentioned roads, between the hours of 12.00 midnight on Sunday, 13th February, 1994 and 9.00 p.m. on Monday, 14th February, 1994, and vehicular traffic is prohibited between the hours of 1.00 a.m. and 9.00 p.m. on Monday, 14th February, 1994: Parking prohibited—roads closed

- (a) Duke Street, between Piccadilly Street and Wrightson Road;
- (b) Park Street, between Flament Street and Charlotte Street;
- (c) Flament Street, between Park Street and Wrightson Road;
- (d) Independence Square North, between Wrightson Road and Duncan Street;
- (e) Independence Square South, between Wrightson Road and Duncan Street;
- (f) Charlotte Street, between Park Street and South Quay;
- (g) Nelson Street;
- (h) Duncan Street, between Prince Street and Queen Street;
- (i) Fraser Street;
- (j) Richmond Street, between Tragarete Road and Independence Square South;
- (k) St. Vincent Street, between Oxford Street and Independence Square South;

- (l) George Street;
- (m) Abercromby Street, between South Quay and Oxford Street;
- (n) Frederick Street, between Independence Square North and Oxford Street;
- (o) Henry Street, between South Quay and Oxford Street;
- (p) Sackville Street;
- (q) Broadway, between Independence Square North and Independence Square South;
- (r) Queen Street, between Duncan Street and Richmond Street.

Parking
prohibited

4. Parking is prohibited from 12.00 midnight on Sunday, 13th February, 1994 to 9.00 p.m. on Monday, 14th February, 1994, on the following roads:

- (a) Duncan Street;
- (b) Piccadilly Street, between Park Street and St. Joseph Road;
- (c) South Quay, between St. Vincent Street and Duncan Street, with the exception of the taxis operating from the northern side of South Quay between St. Vincent Street and Chacon Street;
- (d) Queen Street, between Duncan Street and Piccadilly Street;
- (e) Oxford Street;
- (f) Broadway, between South Quay and Beetham Highway;
- (g) Stone Street.

One-way traffic

5. During the times and on the dates specified in paragraph 3, vehicular traffic shall proceed as follows:

- (a) Queen Street, between Duncan Street and Piccadilly Street—in all easterly direction only;
- (b) Piccadilly Street, between Park Street and Prince Street—in a southerly direction only;
- (c) Stone Street, between Wrightson Road and Park Street—in a southerly direction only.

Two-way traffic

6. During the times and on the dates specified in paragraph 3 vehicular traffic shall proceed in both directions along Piccadilly Street, between Prince Street and Queen Street.

Taxi stands

7. From 1.00 a.m. on Monday, 14th February, 1994, to 12.00 midnight on Tuesday, 15th February, 1994, taxis shall operate as follows:

- (a) taxis assigned to taxi stands on and in the vicinity of Independence Square North, between Chacon Street and Cipriani Circle, shall operate from the eastern side of Broadway, between Independence Square South and South Quay, entering and leaving by way of South Quay;

- (b) taxis assigned to taxi stands on Independence Square North, between St. Vincent Street and Abercromby Street, shall operate from the western side of Broadway, between Independence Square South and South Quay;
- (c) taxis assigned to taxi stands on Independence Square other than those referred to in subparagraphs (a) and (b) shall operate from the northern side of South Quay, between St. Vincent Street and Chacon Street.

CARNIVAL MONDAY AND TUESDAY

8. (1) On Monday, 14th February, 1994, from 1.00 a.m. to 9.00 p.m. and on Tuesday, 15th February, 1994, from 6.00 a.m. to 9.00 p.m. parking is prohibited on the roads specified in subparagraph (2), and all roads lying in and within the specified roads. Parking prohibited—roads closed

(2) On Monday, 14th February, 1994, from 10.00 a.m. to 9.00 p.m. and on Tuesday, 15th February, 1994, from 9.00 a.m. to 9.00 p.m. vehicular traffic is prohibited on the following roads, and all roads lying in and within the specified roads:

- (a) Queen's Park West, from Queen's Park East to the entrance to the Queen's Park Savannah opposite Casuals Club;
- (b) Independence Square North and Independence Square South, from Wrightson Road to Duncan Street;
- (c) Nelson Street;
- (d) Duke Street, from Piccadilly Street to Wrightson Road;
- (e) Henry Street;
- (f) Abercromby Street;
- (g) St. Vincent Street;

- (k) Duncan Street, between Queen Street and Prince Street;

9. (1) On Monday, 14th February, 1994, from 1.00 a.m. to 9.00 p.m. and on Tuesday, 15th February, 1994, from 6.00 a.m. to 9.00 p.m. parking is prohibited on the following roads:

(2) From 10.00 a.m. to 12.00 midnight on Monday, 14th February, 1994, and on Tuesday, 15th February, 1994, parking is prohibited on the following roads:

- (a) that portion of South Quay and Eastern Main Road between Piccadilly Street, Port-of-Spain and Bushe Street, San Juan;
- (b) that portion of the Beetham Highway, between Broadway and St. Vincent Street.

10. During the times and on the dates specified in paragraph 8(1), One-way traffic vehicular traffic shall proceed as follows:

- (a) on Queen Street, between Duncan Street and Piccadilly Street—in an easterly direction;

- (b) on Piccadilly Street, between Park Street and Prince Street—in a southerly direction;
- (c) on Observatory Street, between Basilon Street and Belmont Circular Road—in a northerly direction and between Belmont Circular Road and Quarry Street—in a southerly direction;
- (d) on Basilon Street—in a westerly direction;
- (e) on Archer Street, between Belmont Circular Road and Jerningham Avenue—in a southerly direction;
- (f) on Cadiz Road—in an easterly direction only;
- (g) on Luis Street, between Ariapita Avenue and Tragarete Road—in a northerly direction only.

Two-way traffic

11. (1) During the times and on the dates specified in paragraph 8(1), vehicular traffic shall proceed in both directions along Piccadilly Street, between Prince Street and Queen Street.

(2) Notwithstanding any enactment to the contrary, from 6.00 a.m. on Monday, 14th February, 1994 to 6.00 a.m. on Wednesday, 16th February, 1994, vehicular traffic may proceed in both directions around the Queen's Park Savannah, between Cadiz Road and Maraval Road by way of Circular Road.

Taxi stand

12. From 1.00 a.m. on Monday, 14th February, 1994, to 12.00 midnight on Tuesday, 15th February, 1994, taxis assigned to the taxi stand on Victoria Avenue shall operate from Cummins Lane.

Route for emergency vehicles to Port-of-Spain General Hospital

13. Vehicles proceeding to the Port-of-Spain General Hospital on an emergency shall travel along the following routes and leave by the said route:

- (a) from the east—may enter Duncan Street from South Quay proceeding into Queen Street, north along Piccadilly Street, east on Laventille Hill, north on Quarry Street into Observatory Street, Belmont Circular Road, entering the Hospital from the mortuary entrance;
- (b) from the west—Circular Road, Queen's Park East, Belmont Circular Road entering the Hospital by way of the mortuary entrance.

Bands approach to and departure from the Queen's Park Savannah

14. Bands shall enter the Queen's Park Savannah Competition Centre through the entrance on Frederick Street, and bands from Belmont shall enter the Queen's Park Savannah from Jerningham Avenue and shall leave through either exits on Queen's Park West.

Bands approach to and departure from Adam Smith Square Competition Centre

15. Bands shall approach the Adam Smith Square Competition Centre by way of Alexandra Street or Tragarete Road, turning south into Carlos Street, then proceeding eastwards along Ariapita Avenue and continuing.

16. Bands shall approach the Victoria Square Competition Centre by proceeding eastwards along Ariapita Avenue, turning into Park Street, and shall leave by continuing eastwards along Park Street, and north along Abercromby Street. Bands approach to and departure from Victoria Square Competition Centre

17. Bands shall approach the Independence Square Competition Centre by way of St. Vincent Street and Richmond Street, eastwards along Independence Square South, north along George Street, west along Independence Square North, and shall leave by way of Frederick Street, Chacon Street or Abercromby Street. Bands approach to and departure from Independence Square Competition Centre

18. Vehicles shall enter the Queen's Park Savannah at the following points: Entry of vehicles into the Queen's Park Savannah

- (a) Queen's Park East, near St. Ann's Roundabout;
- (b) Queen's Park West, opposite Dundonald Street;
- (c) Queen's Park West, opposite Casuals Club;
- (d) Circular Road, opposite President's House;
- (e) Maraval Road, opposite Whitehall.

19. Parking on the Queen's Park Savannah shall be in accordance with the directions of the police officer on duty. Parking on the Queen's Park Savannah

PART II

SAN JUAN

20. This Part has effect during the times and on the dates specified in paragraphs 21 and 23. Commencement and cessation

21. On Sunday 13th, Monday 14th and Tuesday 15th February, 1994, parking is prohibited on Saddle Road, between Prizgar Road and Eastern Main Road, between the hours of 10.00 a.m. and 6.00 p.m. Parking prohibited

22. On Sunday, 13th February, 1994, vehicular traffic is prohibited on Saddle Road, between Real Street and Eastern Main Road, between the hours of 12.00 noon and 6.00 p.m. Road closed

23. On Monday, 14th February and Tuesday, 15th February, 1994, parking and vehicular traffic are prohibited between the hours of 10.00 a.m. and 9.00 p.m. on the following roads: Roads closed—parking prohibited

- (a) Saddle Road, between Real Street and Eastern Main Road;
- (b) First Street, between Eastern Main Road and First Avenue;
- (c) Colda Tinda Avenue;
- (d) Second Street, between First Avenue and First Street.

PART III

CUREPE

- Commencement and cessation 24. This Part has effect between the hours of 1.00 p.m. and 7.00 p.m. on the following days:
- (a) Monday, 14th February, 1994;
 - (b) Tuesday, 15th February, 1994.
- Parking prohibited 25. No vehicles shall be permitted to park or wait on Southern Main Road between Eastern Main Road and Churchill-Roosevelt Highway.
- Vehicular traffic 26. Vehicular traffic shall proceed as follows:
- (a) vehicles proceeding south along Southern Main Road will be diverted east along Evans Street, south along McDonald Street and return to Southern Main Road by way of the East to West Streets except Clifford Street;
 - (b) vehicles proceeding east along Eastern Main Road shall travel north along Frederick Street, east into Sellier Street and south along Francis Street into Eastern Main Road;
 - (c) vehicles proceeding west along Eastern Main Road shall travel south into Belle-Smythe Street, west into Evans Street, north along Southern Main Road, then west into Eastern Main Road.

PART IV

TUNAPUNA

- Commencement and cessation 27. This Part has effect between the hours of 12.00 noon and 7.00 p.m. on the following days:
- (a) Monday, 14th February, 1994;
 - (b) Tuesday, 15th February, 1994.
- Parking prohibited 28. Parking is prohibited on:
- (a) Macoya Road;
 - (b) Eastern Main Road between Caura Royal Road and St. John's Road.
- Vehicular traffic 29. Vehicular traffic shall proceed as follows:
- (a) vehicles proceeding east along Eastern Main Road shall be diverted along Auzonville Road, east along Hendrickson Street, south along Tunapuna Road, east along Green Street and south along El Dorado Road to Eastern Main Road;
 - (b) vehicles proceeding west along Eastern Main Road shall turn south along Macoya Road, west along Churchill-Roosevelt Highway, north along the entrance to the University of the West Indies, west along Watts Trace, north along Evans Street and continuing onto Eastern Main Road.

PART V

AROUCA

30. This Part has effect between the hours of 12.00 noon and 7.00 p.m. on the following days: Commencement and cessation

- (a) Monday, 14th February, 1994;
- (b) Tuesday, 15th February, 1994.

31. Parking is prohibited on Eastern Main Road, between Arima Old Road and the Tacarigua Bridge. Parking prohibited

PART VI

ARIMA

32. This Part has effect between the hours of 12.00 noon and 10.00 p.m. on: Commencement and cessation

- (a) Monday, 14th February, 1994;
- (b) Tuesday, 15th February, 1994.

33. (1) Vehicular traffic entering Arima shall proceed as follows: Vehicular routes

- (a) from the west—along Eastern Main Road, north into Industry Street, east along Anglican Street, and north along King Street, east along Sanchez Street and south along Prince Street;
- (b) from the east—along Guanapo Street, south into Quesnel Street continuing west and then south into Pro Queen Street;
- (c) from the south—along Cocorite Street, west into Quesnel Street, or along O'Meara Road, north into Railway Road, into Industry Street.

(2) Vehicles proceeding to the Arima Fire Station or the Arima Police Station, shall do so by way of Green Street.

34. Parking and vehicular traffic are prohibited on the following roads: Roads closed—parking prohibited

- (a) Broadway, between St. Joseph Street and Raglan Street;
- (b) Queen Street, between Sorzano Street and Hollis Avenue;
- (c) Hollis Avenue, between Industry Street and Queen Street;
- (d) Prince Street, between Sorzano Street and Broadway;
- (e) Cocorite Street, between Broadway and Quesnel Street;
- (f) Woodford Street, between Hollis Avenue and Sorzano Street.

35. Parking is prohibited on the following roads: Parking prohibited

- (a) Quesnel Street, between Guanapo Street and Pro Queen Street;

- (b) Moreno Street, between Guanapo Street and Columbus Street;
- (c) Sorzano Street, between Columbus Street and King Street;
- (d) Sanchez Street, between King Street and Prince Street;
- (e) King Street, between Hollis Avenue and Sanchez Street;
- (f) Anglican Street, between Industry Street and King Street;
- (g) Green Street, between Cocorite Road and King Street;
- (h) Farfan Street, between Cocorite Road and King Street;
- (i) Prince Street, between Broadway and Sorzano Street;
- (j) Raglan Street, between Broadway and Sorzano Street, with the exception of maxi taxis whose terminus will be on this street.

Temporary bus routes

36. Public Transport Service Corporation buses shall proceed as follows:

- (a) buses approaching Arima from the east, along Guanapo Street, shall travel south into Quesnel Street continuing south into Pro Queen Street, west along Robinson Circular into St. Mary Avenue, Hollis Avenue onto the terminus;
- (b) buses proceeding to Sangre Grande will do so by proceeding north along King Street, east along Sorzano Street, then east along Columbus Street onto Moreno Street, then east into Guanapo Street;
- (c) buses proceeding to Port-of-Spain will travel north along King Street, west along Industry Street onto John Shaw Avenue.

Parking restricted

37. Parking is permitted on the following roads:

- (a) St. Joseph Street, between Farfan Street and Longden Street on the western side;
- (b) Guanapo Street, between Moreno Street and Raglan Street on the southern side.

PART VII

SANGRE GRANDE

Commencement and cessation

38. This Part has effect between the hours of:

- (a) 11.00 a.m. and 7.00 p.m. on Monday, 14th February, 1994; and
- (b) 11.00 a.m. and 10.00 p.m. on Tuesday, 15th February, 1994.

Vehicular routes

39. Vehicular traffic shall proceed as follows:

- (a) vehicles proceeding east along Eastern Main Road shall be diverted north into Picton Road, east along Goodhope Street into Ojoe Road, south along Ojoe Road, east into River Street, south into Henderson Street, east into Brierley Street and south into Boodooville;

- (b) traffic proceeding west along Eastern Main Road shall be diverted north into Savi Street, west along Toco Road, north along Henderson Street, west along Brierley Street, north along Foster Road, west along River Street, north along Ojoe Road, west along Adventist Street, south along Ramdass Street and west along Eastern Main Road;
- (c) traffic proceeding north along Cunapo Southern Main Road towards Eastern Main Road shall proceed west into Juteram Street, north into Paul Street and west along Eastern Main Road;
- (d) traffic proceeding into Cunapo Southern Main Road shall proceed south into Paul Street, east into Mary Street and south into Cunapo Southern Main Road.

40. Parking is prohibited on the following roads:

Parking

- (a) Eastern Main Road, between Picton Road and Sangre Grande Roundabout;
- (b) Picton Road, south of Goodhope Street;
- (c) Adventist Street, between Picton Road and Ojoe Road;
- (d) Foster Road, between Toco Road and Brierley Street;
- (e) Ojoe Road, between Goodhope Street and Sangre Grande Roundabout;
- (f) Brierley Street, between Toco Road and Ojoe Road;
- (g) Mary Street;
- (h) Savi Street and Boodooville;
- (i) Paul Street;
- (j) Henderson Street;
- (k) Goodhope Street, between Picton Road and Ojoe Road;
- (l) River Street, between Foster Road and Ojoe Road.

41. Taxis may ply for hire as follows:

Temporary taxi
stands

- (a) taxis plying from Sangre Grande to Port-of-Spain, shall park on Eastern Main Road, west of Ramdass Street facing west on the southern side of the road;
- (b) taxis plying the Manzanilla/Mayaro and Fishing Pond routes shall park east of the 29½ mile mark along Eastern Main Road facing east on the northern side of the road;
- (c) taxis plying from Sangre Grande to Matura, Toco and Matelot, shall park on the northern side of the Toco Road, east of Brierley Street facing east;
- (d) taxis plying between Biche and Sangre Grande, shall park on the eastern side of the Cunapo Southern Main Road, south of Mary Street facing south;
- (e) taxis plying the Hospital route (Foster Road) shall park on the western side of Foster Road north of River Street facing north.

Temporary bus routes

42. Public Transport Service Corporation buses shall proceed as follows:

- (a) buses operating from Manzanilla and Toco, shall approach the terminus in Sangre Grande via Ojoe Road and Brierley Street;
- (b) buses operating from Arima shall approach the Terminus in Sangre Grande via Picton Road and Brierley Street.

Two-way traffic

43. Traffic may proceed in both directions on Brierley Street between Railway Road and Toco Road during the Carnival period.

PART VIII

CHAGUANAS

Commencement and cessation

44. This Part has effect between the hours of:

- (a) 7.00 a.m. and 9.00 p.m. on Monday, 14th February, 1994; and
- (b) 9.00 a.m. and 12.00 midnight on Tuesday, 15th February, 1994.

Parking prohibited

45. Parking is prohibited on the following roads:

- (a) Chaguanas Main Road, between Old Southern Main Road and Endeavour Road and between Laing Street and Caroni Savannah Road;
- (b) Eleanor Street, between Old Southern Main Road and Marie Street;
- (c) Caroni Savannah Road, between Chaguanas Main Road and Uriah Butler Turn Off;
- (d) Rennie Street, between Caroni Savannah Road and St. Yves Street;
- (e) St. Yves Street, between Rennie Street and Chaguanas Main Road;
- (f) Rudranath Capildeo Road, between St. Yves Street and Endeavour Road;
- (g) Endeavour Road, between Rudranath Capildeo Road and Chaguanas Main Road;
- (h) Old Southern Main Road, between Chaguanas Main Road and Ramsaran Street.

Roads closed

46. Vehicular traffic is prohibited on the following roads:

- (a) Chaguanas Main Road, between Endeavour Road and Old Southern Main Road and between Marie Street and St. Yves Street;
- (b) Marc Street, between Eleanor Street and Chaguanas Main Road;
- (c) Market Street, between Eleanor Street and Chaguanas Main Road;
- (d) Longdenville Main Road, between Peer Bachus Street and Enterprise Street.

47. Vehicular traffic shall proceed as follows:

One-way traffic

- (a) along Endeavour Road, between Chaguanas Main Road and Rudranath Capildeo Street, in a southerly direction;
- (b) along Railway Road East, between Laing Street and Chaguanas Main Road, in a southerly direction;
- (c) along Railway Road West, in a northerly direction.

48. Vehicular traffic entering or leaving Chaguanas shall proceed as follows:

Vehicular routes

- (a) traffic to Chaguanas from Montrose Village and Port-of-Spain shall proceed south into Old Southern Main Road, west into Ramsaran Street, to Railway Road West, and North into Caroni Savannah Road;
- (b) traffic to Chaguanas from San Fernando shall proceed west into Ramsaran Street, then into Railway Road West;
- (c) traffic leaving Chaguanas from the Police Station shall proceed north along Caroni Savannah Road, east into Uriah Butler Highway;
- (d) traffic from Rudranath Capildeo Road to San Fernando and Montrose shall proceed south into Endeavour Road to Chaguanas Main Road;
- (e) traffic from Rudranath Capildeo Road to Port-of-Spain shall turn into Access Street, then west into Rennie Street and north along Caroni Savannah Road;
- (f) traffic from Chaguanas to Longdenville shall proceed north along Enterprise Street, east along Amaroosingh Street and south into Peer Bachus Street;
- (g) traffic from Brasso to Chaguanas shall travel south into Nardanie Street, then west into Nelson Street and north into Damp Road to Longdenville Main Road.

49. Public Transport Service Corporation buses from Port-of-Spain and Brasso shall use the temporary terminus at Railway Road at the entrance to the north-bound carriageway, Uriah Butler Highway from Chaguanas Main Road.

Temporary bus terminus

50. Public Transport Service Corporation buses from San Fernando shall travel along the Old Southern Main Road through Chase Village and turn east into the temporary terminus at the junction of Chaguanas Main Road.
