ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 1993

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Labour Day Celebrations—Fyzabad) Order, 1993. Citation

2. This Order has effect between the hours of 5.00 a.m. and 7.00 p.m. on Saturday, 19th June, 1993. Duration

3. No person shall park a motor vehicle on—

- (a) Fyzabad-Guapo Road, between No. 37 Road (near to the Hi-Lo Supermarket) and Gowers Well Road and Charlie King Junction;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Siparia-Fyzabad Road;
- (d) Siparia-Fyzabad Road, between Coolman Trace and Sanderson Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
- (g) Fyzabad-Oropouche Road, between Delhi Road and Morteil Trace;
- (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road.

Parking prohibited

4. Subject to paragraph 5, vehicular traffic is prohibited—

- (a) onto Fyzabad-Guapo Road from Khan Trace;
- (b) between the hours of 9.00 a.m. and 7.00 p.m. on—
 - (i) Fyzabad-Guapo Road, between Gowers Well Road and Charlie King Junction;
 - (ii) Fyzabad-Oropouche Road, between Delhi Road and Fyzabad-Guapo Road.

Roads closed

5. Public Transport Service Corporation buses may ply their normal routes. Bus routes

6. Motorists approaching—

- (a) Oropouche from Fyzabad, along Fyzabad-Guapo Road, shall proceed in a north-westerly direction, into Gowers Well Road, North into Campbell Trace, north-west into Khan Trace, north-east into Delhi Road and then North into Fyzabad-Oropouche Road; Alternative routes

- (b) Siparia from Fyzabad, along Guapo Road, shall proceed in a north-easterly direction, into Easy Street, continuing north-east into Coolman Trace and then North into Siparia-Fyzabad Road;
- (c) Forest Reserve from Oropouche, along Lum Tack Hill, shall proceed North into Siparia-Fyzabad Road, South into Sanderson Avenue into Fyzabad-Guapo Road;
- (d) Siparia from Forest Reserve, shall proceed in a south-westerly direction, into Sanderson Avenue and then South into Siparia-Fyzabad Road;
- (e) Siparia from Delhi Road, along Lum Tack Hill, shall proceed East into Siparia-Fyzabad Road;
- (f) Delhi Road from Siparia, shall proceed South into Sanderson Avenue, north-east into Fyzabad-Guapo Road, north-west into Gowers Well Road, continuing north-west into John Jules Trace and then south-east into Delhi Road;
- (g) Siparia from Oropouche, along Lum Tack Hill, shall proceed North into Siparia-Fyzabad Road; and
- (h) Oropouche from Siparia, South into Sanderson Avenue, north-east into Fyzabad-Guapo Road, north-west into Gowers Well Road, continuing north-west into John Jules Trace, south-east into Delhi Road and then North into Oropouche Road.

Removal and
impounding
of vehicles

7. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
