ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ST. PETER'S DAY CELEBRATIONS) (CARENAGE) ORDER, 1993

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (St. Peter's Day Celebrations) (Carenage) Order, 1993. Citation

2. This Order has effect between the hours of 10.00 a.m. and 10.00 p.m. on Sunday, 4th July, 1993. Duration

3. Parking is prohibited on the following roads: Parking prohibited
 - (a) Haig Street, between Western Main Road and Francois Street;
 - (b) Beard Street, between Western Main Road and Francois Street;
 - (c) Constabulary Street, between Western Main Road and Sobrian Street;
 - (d) Western Main Road, between Dhien's Bay and Alcoa Main Gate;
 - (e) Hope Street;
 - (f) Abbe Poujade Street, between Western Main Road and Haig Street;
 - (g) School Street, between Western Main Road and Francois Street;
 - (h) Francois Street, between School Street and Beard Street.

4. (1) West bound traffic shall proceed— One-way traffic
 - (a) in a northerly direction only, along Constabulary Street, between Western Main Road and Sobrian Street;
 - (b) in a westerly direction only, along Sobrian Street;
 - (c) in a northerly direction only, along Beard Street, between Sobrian Street and Hope Street;
 - (d) in a westerly direction only, along Hope Street, between Beard Street and Haig Street;
 - (e) in a southerly direction only, along Haig Street, between Hope Street and Raymond Street;
 - (f) in a westerly direction only, along Raymond Street, between Haig Street and Abbe Poujade Street;
 - (g) in a southerly direction only, on Abbe Poujade Street, between Raymond Street and Western Main Road.

- (2) East bound traffic shall proceed—
 - (a) in a northerly direction only, on Abbe Poujade Street, between Western Main Road and Haig Street;
 - (b) in a southerly direction only, along Haig Street, between the intersection of Abbe Poujade Street, Haig Street and Hope Street;
 - (c) in an easterly direction only, along Hope Street, between Haig Street and Beard Street;

- (d) in a southerly direction only, along Beard Street, between Hope Street and Francois Street;
- (e) in an easterly direction only, along Francois Street, between Beard Street and School Street; and
- (f) in a southerly direction only, along School Street, between Francois Street and Western Main Road.

Roads closed 5. Vehicular traffic is prohibited on the Western Main Road, between Abbe Poujade Street and Constabulary Street.

Regular routes 6. Notwithstanding the provisions of this Order, Public Transport Service Corporation buses, large Defence Force vehicles and Fire Service vehicles may proceed along their regular routes.

Two-way traffic 7. Traffic shall travel in both directions on Abbe Poujade Street between Western Main Road and Haig Street.

Removal and impounding of vehicles unlawfully parked
Chap. 48:50 8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
