ORDER

MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(HOSEIN) ORDER, 1993

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Hosein) Order, 1993.

2. This Order shall have effect— Duration
- (a) from 10.00 p.m. on Monday, 28th June, 1993 to 4.00 a.m. on Tuesday, 29th June, 1993;
 - (b) from 10.00 p.m. on Tuesday, 29th June, 1993 to 4.00 a.m. on Wednesday, 30th June, 1993;
 - (c) from 10.00 p.m. on Wednesday, 30th June, 1993 to 4.00 a.m. on Thursday, 1st July, 1993;
 - (d) from 10.00 a.m. to 8.00 p.m. on Thursday, 1st July, 1993.

3. On the dates and during the times specified in paragraph 2, drivers One-way traffic
on the roads mentioned below shall proceed as follows:

- (a) Lazare Street, between Western Main Road and Carlton Avenue, in a southerly direction only;
- (b) Jerry Street, between Church Street and Western Main Road, in a southerly direction only;
- (c) Ethel Street, between Western Main Road and Bay Road, in a southerly direction only;
- (d) Bournes Road, between Western Main Road and Church Street, in a northerly direction only;
- (e) Brunton Road, between Western Main Road and Church Street, in a northerly direction only;
- (f) Mooneram Street, between Western Main Road and Church Street, in a northerly direction only;
- (g) Bombay Street, between Western Main Road and Church Street, in a northerly direction only;
- (h) Clarence Street, between Western Main Road and Anderson Street, in a southerly direction only;
- (i) Vidale Street, between Western Main Road and Anderson Street, in a southerly direction only;
- (j) Dengue Street, between Western Main Road and Anderson Street, in a southerly direction only.

4. On the dates and during the times specified in paragraph 2, parking Parking prohibited
is prohibited on—

- (a) Western Main Road, between Fort George and Tragarete Roads;
- (b) Quamina Street, between Brunton Road and Bournes Road;
- (c) Mathura Street, between Western Main Road and Carlton Avenue;
- (d) Serpentine Road;

- (e) Mary Street;
- (f) Hayes Street, between Mary Street and Serpentine Road;
- (g) Clarence Street; and
- (h) Agra Street, between Western Main Road and Madras Street.

5. Vehicular traffic is prohibited on the Western Main Road, between Long Circular Road and George Cabral Street.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
