AN ACT to amend the Income Tax Ordinance, Ch. 33. No. 1.

[Assented to 13th April, 1972]

BE IT ENACTED by the Queen's Most Excellent Majesty, by ^{Enactment} and with the advice and consent of the Senate and House of Representatives of Trinidad and Tobago, and by the authority of the same, as follows:

1. This Act may be cited as the Income Tax (Amend- ^{Short title} ment) (No. 2) Act, 1972.

2. Section 16 of the Income Tax Ordinance is amended by inserting the following new subsection after subsection (1) thereof:—

“(1A) Nothing in subsection (1)(d) shall apply to so much of the contribution of an employed person who is registered or eligible to be registered under the system of national insurance established by the National Insurance Act, 1971, as is paid out of contributions of a contributor under the Widows’ and Orphans’ Pensions Ordinance in accordance with section 18(3) thereof.”
