MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 68(1) OF THE  
MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)  
(HOSEIN) ORDER, 1982

1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (Hosein) Order, 1982. Citation

2. This Order shall come into operation at 10.00 p.m. on Monday, 25th October, and shall cease at 7.00 p.m. on Thursday, 28th October, 1982. Commencement and cessation

3. Between the hours of—

- (a) 10.00 p.m. on Monday, 25th October, 1982 and 4.00 a.m. on Tuesday, 26th October, 1982; One-way traffic
- (b) 10.00 p.m. on Tuesday, 26th October, and 4.00 a.m. on Wednesday, 27th October, 1982;
- (c) 10.00 p.m. on Wednesday, 27th October and 4.00 a.m. on Thursday, 28th October, 1982;
- (d) 10.00 a.m. and 7.00 p.m. on Thursday, 28th October, 1982.

Vehicular traffic on the undermentioned roads shall proceed as follows—

- (i) Lazare Street between Carlton Avenue and Western Main Road—in a southerly direction only;
- (ii) Jerry Street between Church Street and Western Main Road—in a northerly direction only;
- (iii) Ethel Street between Bay Road and Western Main Road—in a southerly direction only;
- (iv) Bournes Road between Church Street and Western Main Road—in a northerly direction only;
- (v) Brunton Road between Church Street and Western Main Road—in a northerly direction only;
- (vi) Mooneram Street between Church Street and Western Main Road—in a northerly direction only;
- (vii) Bombay Street between Church Street and Western Main Road—in a southerly direction only;
- (viii) Clarence Street between Anderson Street and Western Main Road—in a southerly direction only;

- (ix) Vidale Street between Anderson Street and Western Main Road—in a southerly direction only;
- (x) Dengue Street between Anderson Street and Western Main Road—in a southerly direction only.

Parking  
prohibited

4. (1) During the hours specified in paragraph 3, parking is prohibited on the undermentioned roads—

- (a) Western Main Road, St. James—between Fort George Road and Tragarete Road;
- (b) Brunton Road, St. James—between Quamina Street and Western Main Road;
- (c) Agra Street, St. James—between Madras Street and Western Main Road;
- (d) Clarence Street, St. James.

(2) Between the hours of 10.00 a.m. and 7.00 p.m. on Thursday, 28th October, 1982, parking is prohibited on the undermentioned roads—

- (a) Western Main Road, St. James—between Fort George and Tragarete Roads;
- (b) Brunton Road, St. James—between Quamina Street and Western Main Road;
- (c) Agra Street, St. James—between Madras Street and Western Main Road;
- (d) Serpentine Road, St. Clair;
- (e) Mary Street, St. Clair;
- (f) Hayes Street, St. Clair—between Mary Street and Serpentine Road; and
- (g) Clarence Street, St. James.

Removal and  
impounding  
of vehicles

5. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, shall be removed by the Police and impounded or otherwise dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
