MADE BY THE COMMISSIONER OF POLICE UNDER SECTION 44F(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ORDINANCE

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS)
(ENGLAND CRICKET TOUR) ORDER, 1981

Citation 1. This Order may be cited as the Traffic Restriction (Temporary Provisions) (England Cricket Tour) Order, 1981.

Commencement and cessation 2. This Order shall be effective between the hours of 6.00 a.m. and 6.00 p.m. on each of the following dates:

- Saturday, 7th February, 1981;
- Sunday, 8th February, 1981;
- Monday, 9th February, 1981;
- Tuesday, 10th February, 1981;
- Friday, 13th February, 1981;
- Saturday, 14th February, 1981;
- Monday, 16th February, 1981;
- Tuesday, 17th February, 1981; and
- Wednesday, 18th February, 1981.

Parking prohibited 3. During the dates and on the times shown in paragraph 2, no person may park or cause or permit any vehicle to be parked or to remain on any of the undermentioned roads—

- (a) Tragarete Road, between Herbert Street and Serpentine Road;
- (b) Havelock Street;
- (c) St. Clair Avenue between Kavanagh Street and Tragarete Road;
- (d) White Street;
- (e) the alley-way between Havelock Street and Broome Street;
- (f) the alley-way between Alexandra Street and Elizabeth Street;
- (g) Rosalino Street between Roberts Street and Tragarete Road;
- (h) Pole Carew Street; and
- (i) Serpentine Road between Tragarete Road and Serpentine Place.

4. During the times and on the dates shown in paragraph 2, parking shall be permitted on the roads and in the manner specified below—

(a) on the eastern side only—

- (i) Kavanagh Street;
- (ii) Broome Street;
- (iii) Alexandra Street;
- (iv) Gray Street;
- (v) Serpentine Place;
- (vi) Gallus Street between Ariapita Avenue and Warren Street;
- (vii) Alberto Street between Ariapita Avenue and Warren Street;
- (viii) Rosalino Street between Ariapita Avenue and Warren Street;
- (ix) Luis Street between Tragarete Road and Roberts Street;
- (x) Alfredo Street between Ariapita Avenue and Tragarete Road;
- (xi) Carlos Street between Ariapita Avenue and Tragarete Road; and
- (xii) Elizabeth Street between St. Clair Avenue and Tragarete Road—herringbone fashion south-west as directed by the Police Officers on duty;

(b) on the western side only—

- (i) Elizabeth Street between St. Helena Avenue and Serpentine Road;
- (ii) Mary Street;

(c) on the northern side only—

- (i) Flood Street;
- (ii) Jackson Street;
- (iii) Hayes Street;
- (iv) Sweet Briar Road;
- (v) Roberts Street between Murray Street and Damian Street;
- (vi) Hunter Street;
- (vii) Brabant Street;
- (viii) St. Clair Avenue between Kavanagh Street and Elizabeth Street;
- (ix) Hamilton Street;

(d) on the southern side only—

- (i) Jackson Square North; and
- (ii) Seigert Square North.

- One-way traffic** 5. Vehicular traffic shall proceed along Havelock Street in a northerly direction only, and along Elizabeth Street between St. Clair Avenue and Tragarete Road in a southerly direction only.
- No Right turn** 6. (1) Vehicular traffic proceeding South along Elizabeth Street may not turn West into Tragarete Road.
(2) Vehicular traffic proceeding West along Sweet Briar Road may not turn North into Elizabeth Street.
- Traffic prohibited** 7. Vehicular traffic is prohibited on that portion of Rosalino Street between Roberts Street and Tragarete Road.
- Removal and impounding of unlawfully parked vehicles**
Ch. 16. No. 3 8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with sections 78B and 78c of the Motor Vehicles and Road Traffic Ordinance.
