MADE BY THE RULES COMMITTEE UNDER SECTION 77 OF THE SUPREME COURT OF JUDICATURE ACT, 1962

THE MATRIMONIAL CAUSES (AMENDMENT) RULES, 1981

1. These Rules may be cited as the Matrimonial Causes (Amendment) Rules, 1981, and shall be read as one with the Matrimonial Causes Rules, 1973 hereinafter referred to as the Principal Rules. G.N. 190/1973

2. The Principal Rules are hereby amended—
