MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE MINISTER  
UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE WESTERN PORT-OF-SPAIN PHASE II TRAFFIC CONTROL  
(EXPERIMENTAL SCHEME) REGULATIONS, 1985

1. These Regulations may be cited as the Western Port-of-Spain Phase II Traffic Control (Experimental Scheme) Regulations, 1985. Citation
  
2. These Regulations come into operation at 5.00 a.m. on Wednesday 1st May 1985, and cease at 5.00 a.m. on Wednesday, 31st July, 1985. Commence-

cessation
  
3. The following roads are four lane two-way roads— Four lane  
two-way  
roads
  - (a) Tragarete Road from Damian Street to White Street;
  - (b) Ariapita Avenue from Maraval Parkway to Park Street.
  
4. Parking is prohibited— Parking  
prohibited
  - (a) on Tragarete Road between Damian Street and Edward Street on Monday to Friday of each week from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m.;
  - (b) on Tragarete Road between St. Vincent Street and Edward Street, except that taxis plying for hire may park on the southern side—facing West;
  - (c) on Ariapita Avenue on Monday to Friday of each week from 6.00 a.m. to 9.00 a.m. and from 3.00 p.m. to 6.00 p.m.;
  - (d) on Park Street between Scott Bushe Street and Victoria Square West;
  - (e) on Park Street between Richmond Street and St. Vincent Street; but taxis plying for hire may park on the northern side between Edward Street and St. Vincent Street;
  - (f) on Richmond Street between Tragarete Road and Park Street;
  - (g) on Edward Street between Park Street and Tragarete Road;
  - (h) on Herbert Street, from Monday to Friday—on the southern side;
  - (i) on Rust Street, from Monday to Friday—on the southern side;
  - (j) on Alcazar Street, from Monday to Friday—on the southern side.

**Parking permitted****5. Parking is permitted—**

- (a) subject to regulation 4, on Tragarete Road between Damian Street and Edward Street—
  - (i) on Monday, Wednesday and Friday—on the southern side;
  - (ii) on Tuesday, Thursday, Saturday and Sunday—on the northern side;
- (b) on Stone Street—
  - (i) on Monday, Wednesday and Friday—on the eastern side;
  - (ii) on Tuesday, Thursday and Saturday—on the western side;
- (c) on Fraser Street—on the northern side;
- (d) on Duke Street between Melbourne Street and Shine Street—on the southern side.

**One-way traffic****6. Vehicular traffic shall proceed as follows—**

- (a) on Tragarete Road between St. Vincent Street and Edward Street in a westerly direction;
- (b) on Park Street between Victoria Square West and Charlotte Street in an easterly direction;
- (c) on Victoria Square East in a southerly direction;
- (d) on Richmond Street in a southerly direction;
- (e) on Victoria Square West in a northerly direction;
- (f) on Fraser Street in an easterly direction;
- (g) on Kew Place between Park Street and Longden Street in a westerly direction.

**Stopping or parking****7. Vehicles may not stop or park—**

- (a) on Tragarete Road within thirty metres of the junction of that road with—
  - (i) French Street;
  - (ii) Cipriani Boulevard; and
  - (iii) Dundonald Street;
- (b) on Ariapita Avenue within thirty metres of the junction of that road with—
  - (i) Ana Street;
  - (ii) Carlos Street;
  - (iii) French Street; and
  - (iv) Colville Street;

- (c) within fifty metres of all approaches to and exits from the intersection of Richmond Street and Park Street, except for buses stopping at bus stops;
- (d) within thirty metres of all approaches to and exits from the intersection of Park Street and St. Vincent Street, except for taxis at the taxi-stands.
