THE FRIENDLY SOCIETIES ORDINANCE, CH. 38. No. 2

REGULATIONS

MADE BY THE GOVERNOR-GENERAL UNDER SECTION 120 OF THE FRIENDLY SOCIETIES ORDINANCE

THE FRIENDLY SOCIETIES (AMENDMENT) REGULATIONS, 1971

1. These Regulations may be cited as the Friendly Societies (Amendment) Regulations, 1971.

2. Part II of the Fourth Schedule to the Friendly Societies Ordinance is amended—

(1) By substituting for paragraph 1 thereof the following—

“1. With effect from the 1st day of January, 1971, societies whose membership is specified in the first column of the table below—

(a) shall pay to auditors appointed pursuant to this Ordinance the fees specified in the second column of the said table; and

(b) are eligible to receive contributions from Government towards the payment of such audit fees to the extent specified in the third column of the said table.

TABLE

<i>Number of Members</i>	<i>Fee</i>	<i>Government Contribution</i>
(a) When a society consists of fifty members or less	\$20.00	The whole of the audit fees
(b) When a society consists of more than fifty and not more than two hundred members—		
For the first fifty	\$20.00	
For each additional twenty-five or part of twenty-five members	\$7.50	The whole of the audit fees
(c) When a society consists of more than two hundred members and not more than one thousand members—		The whole of the audit fees of membership under 500. Seventy-five per cent on membership of 500 but less than 1,500
For the first two hundred members	\$65.00	
For each additional fifty or part of fifty members	\$7.50	
(d) When a society consists of more than one thousand members—		Fifty per cent on membership of 1,500 but less than 2,500
For the first thousand members	\$185.00	Twenty-five per cent on membership of 2,500 but less than 5,000
For each additional hundred or part of one hundred members	\$7.50	No contribution on membership of 5,000 or over”.

(2) (a) In paragraph 4, by substituting for the words "ten dollars (\$10)" the words "twenty dollars (\$20)";

(b) By adding the following new paragraph thereto:—

"5. The Government Contributions in respect of fees payable under paragraph (4) shall be the whole of the audit fees."
