ORDER

MADE BY THE PRESIDENT UNDER SECTION 5(3) OF THE
LAND ACQUISITION ACT

THE LAND ACQUISITION (DECLARATION OF
ACQUISITION) (NO. 2) ORDER, 1996

1. This Order may be cited as the Land Acquisition (Declaration of Citation Acquisition) (No. 2) Order, 1996.

2. The parcels of land—

- (a) comprising 0.6208 of an hectare, more or less, situate at Penal, in the Ward of Siparia, in the County of St. Patrick; Declaration of acquisition of land
- (b) described in the Schedule hereto and coloured raw sienna on a plan of survey signed by the Director of Surveys and dated 14th November, 1995 executed under Survey Order No. 5/95 and filed in the Lands and Surveys Division;
- (c) having been declared by the President with the approval of the Parliament of Trinidad and Tobago by Resolution of the House of Representatives on 19th December, 1996 and the Senate on 20th December, 1996,

have been acquired for the following public purpose: a reserve for water pipelines associated with the generation of electricity.

SCHEDULE

Fourteen parcels of land containing together 0.6208 of an hectare more or less, situate at Penal, in the Ward of Siparia, in the County of St. Patrick and comprised as follows:

- (l) 205.7 m² said to belong now or formerly to Ashley and Carole Leung;
- (m) 985.8 m² said to belong now or formerly to Baby and Prairagh Bajrangee;
- (n) 620.6 m² said to belong now or formerly to Joan Bhagan.
