NOTICE OF LAND LIKELY TO BE REQUIRED FOR A PUBLIC  
PURPOSE

NOTICE is hereby given that it appears to the President that the twelve parcels of land described in the Schedule together comprising 146,380m<sup>2</sup> more or less situate on both sides of the Uriah Butler Highway and the Churchill Roosevelt Highway in the vicinity of the intersection at the Uriah Butler Highway and Churchill Roosevelt Highway, in the Ward of St. Ann's, in the County of St. George are lands likely to be needed for a purpose which in the opinion of the President is a public purpose: Road Improvement to the Interchange of the Uriah Butler Highway and the Churchill-Roosevelt Highway.

SCHEDULE

Twelve parcels of land containing together 146,380m<sup>2</sup> situate between the San Juan River in the West, Nestlé Food Products Limited in the East and between lands of the University of the West Indies in the North and lands of National Housing Authority, Bamboo Settlement No. 3 in the South, in the Ward of St. Ann's, in the County of St. George and comprised as follows:

- (a) a parcel of land comprising approximately 130,000m<sup>2</sup> belonging now or formerly to the University of the West Indies;
- (b) a parcel of land comprising approximately 1,250m<sup>2</sup> belonging now or formerly to Nestlé Trinidad and Tobago Limited;
- (c) a parcel of land comprising approximately 2,000m<sup>2</sup> belonging now or formerly to Deonarine Sookdeo and occupied by Dooroop Khoon Khoon;
- (d) a parcel of land comprising approximately 5000m<sup>2</sup> belonging now or formerly to Yussuff Ali and occupied by Dorothy Latchu and Karmoon Jamurath;
- (e) a parcel of land comprising approximately 5000m<sup>2</sup> belonging now or formerly to Saith Latchu;
- (f) a parcel of land comprising approximately 1,300m<sup>2</sup> belonging now or formerly to Chanardaye Maharaj;
- (g) a parcel of land comprising approximately 700m<sup>2</sup> belonging now or formerly to Sewnarine Maharaj;
- (h) a parcel of land comprising approximately 400m<sup>2</sup> belonging now or formerly to Samaroo Ragoobar;
- (i) a parcel of land comprising approximately 400m<sup>2</sup> and identified as Lot No. 193 belonging now or formerly to National Housing Authority and occupied by Devananad Basdeo;
- (j) a parcel of land comprising approximately 250m<sup>2</sup> and identified as Lot No. 192 belonging now or formerly to National Housing Authority and occupied by Devananad Basdeo;

- (k) a parcel of land comprising approximately 60m<sup>2</sup> and identified as Lot No. 183 belonging now or formerly to National Housing Authority and occupied by Rudy Evans Sookdeo;
- (l) a parcel of land comprising approximately 20m<sup>2</sup> and identified as Lot No. 337 belonging now or formerly to National Housing Authority and occupied by Kenneth Ramdeen.
