NOTICE OF LAND LIKELY TO BE REQUIRED FOR A PUBLIC PURPOSE

Notice is hereby given that it appears to the President that the parcels and together comprising 9100 square metres more or less, described in the Schedule and situate on both sides of the Churchill-Roosevelt Highway and on the western side of the Uriah Butler Highway between St. Joseph River in the east and on the west by Lots Nos. 69 and 86 on the western side of the Uriah Butler Highway between Lots Nos. 1 and 6, Bamboo Settlement No. 1 in the Ward of St. Ann's in the County of St. George are lands likely to be needed for a purpose which in the opinion of the President is a public purpose: Road Improvement to the Churchill-Roosevelt and Uriah Butler Highways.

SCHEDULE

Sixteen parcels of land containing together 9100 square metres more or less, situate between the St. Joseph River in the east and on the west by Lots Nos. 69 and 86 adjoining to Aranguéz Estates Limited (In Voluntary Liquidation) and on the western side of the Uriah Butler Highway, between Lots Nos. 1 and 6, Bamboo Settlement No. 1 in the Ward of St. Ann's in the County of St. George and described as follows:

- (a) a parcel of State land comprising approximately 400 square metres and leased now or formerly to Rafeek Mohammed Ali;
- (b) a parcel of State land comprising approximately 800 square metres and leased now or formerly to Savitri Sant and Dolsin Sant;
- (c) a parcel of State land comprising approximately 400 square metres and leased now or formerly to Flora Jamurath;
- (d) a parcel of State land comprising approximately 250 square metres and leased now or formerly to Jonas Jamurath;
- (e) a parcel of State land comprising approximately 150 square metres and leased now or formerly to Ramdeo Ramashai;
- (f) a parcel of State land comprising approximately 100 square metres and leased now or formerly to Joseph Jamurath;
- (g) a parcel of State land comprising approximately 800 square metres and leased now or formerly to Jeffrey Jamurath;
- (h) a parcel of State land comprising approximately 2500 square metres and leased now or formerly to Co-operative Citrus Growers Association;
- (i) a parcel of State land comprising approximately 250 square metres belonging now or formerly to Rasheeda Ali and Reswana Ali;

(j) a parcel of State land comprising approximately 1450 square metres belonging now or formerly to Rasheeda Ali and Reswana Ali;

- (k) a parcel of State land comprising approximately 750 square metres below now or formerly to Aranguez Estates Limited (In Voluntary Liquidation);
- (l) a parcel of State land comprising approximately 750 square metres below now or formerly to Naresh Dookhan;
- (m) a parcel of State land comprising approximately 250 square metres below now or formerly to Mobarack Ali;
- (n) a parcel of State land comprising approximately 350 square metres below now or formerly to Esau Hosein;
- (o) a parcel of State land comprising approximately 650 square metres below now or formerly to Aranguez Estates Limited (In Voluntary Liquidation);
- (p) a parcel of State land comprising approximately 250 square metres below now or formerly to Aranguez Estates Limited (In Voluntary Liquidation).
