NOTICE OF LAND LIKELY TO BE REQUIRED FOR A
PUBLIC PURPOSE

NOTICE is hereby given that it appears to the President that four corridors of land traversing several parcels of land situate in the Wards of Naparima and Savana Grande in the County of Victoria, the first and main corridor of which commences west of the Solomon Hochoy Highway in the Ward of Naparima in the County of Victoria and ends at a portion of land known as the Buen Intento Estate in the Ward of Savana Grande in the County of Victoria, the second of which commences at a point along the main corridor in the Ward of Savana Grande in the County of Victoria, and ends at Malgre Toute in the Ward of Savana Grande in the County of Victoria, the third of which commences at a point along the main corridor in the Ward of Savana Grande in the County of Victoria and ends at Matilda Junction in the Ward of Savana Grande in the County of Victoria, the fourth of which commences at Palmyra situate in the Ward of Naparima in the County of Victoria and ends at Golconda in the Ward of Naparima in the County of Victoria are lands likely to be needed for a purpose which in the opinion of the President is a public purpose: the construction of the Highway between San Fernando and Princes Town with connecting access routes.

SCHEDULE

Four corridors of land traversing several parcels of land situate in the Wards of Naparima and Savana Grande in the County of Victoria, the first and main corridor of which commences west of the Solomon Hochoy Highway in the Ward of Naparima in the County of Victoria and ends at a portion of land known as the Buen Intento Estate in the Ward of Savana Grande in the County of Victoria, the second of which commences at a point along the main corridor in the Ward of Savana Grande in the County of Victoria and ends at Malgre Toute in the Ward of Savana Grande in the County of Victoria, the third of which commences at a point along the main corridor in the Ward of Savana Grande in the County of Victoria and ends at Matilda Junction in the Ward of Savana Grande in the County of Victoria, the fourth of which commences at Palmyra situate in the Ward of Naparima in the County of Victoria and ends at Golconda in the Ward of Naparima in the County of Victoria.
