ORDER

MADE BY THE LAW REVISION COMMISSION WITH THE APPROVAL OF THE MINISTER OF LEGAL AFFAIRS UNDER SECTION 6.

THE LAW REVISION ORDER, 1990

1. This Order may be cited as the Law Revision Order, 1990.
