REGULATIONS

MADE BY THE BOARD OF MANAGEMENT UNDER SECTION 42 OF THE NATIONAL INSURANCE ACT, 1971

THE NATIONAL INSURANCE (CONTRIBUTION) (AMENDMENT) REGULATIONS, 1980

1. These Regulations may be cited as the National Insurance (Contribution) (Amendment) Regulations, 1980. Citation

2. The National Insurance (Contribution) Regulations, 1972 is amended— Regulation 10 of G.N. No. 63 of 1972 repealed and replaced

(a) by repealing and replacing regulation 10 as follows—

"Rate of voluntary contribution

10. (1) Subject to paragraph (2) a person who holds a certificate of voluntary insurance shall pay voluntary contribution at the rate for the earnings class into which he falls. Such earnings class shall be based on his average weekly earnings for the period spent in insurable employment during the two years immediately preceding his application for such certificate, that is to say he shall pay as set out hereunder—

(2) A person who began paying voluntary contribution before 1st January, 1980, shall as from 1st January, 1980, pay contribution at the rates for the earnings class shown

in the second column below corresponding to the earnings class in which he paid contribution prior to 1st January, 1980 as set out in the first column below—

(b) in the Second Schedule by deleting the last five items appearing in the third and fourth columns of the Table of Age Credits.
