THE PURCHASE, SWEEPSTAKE, DEPARTURE AND AIRLINE  
TICKET TAXES ORDER, 1987

1. This Order may be cited as the Purchase, Sweepstake, Departure Citation  
and Airline Ticket Taxes Order, 1987.

2. The Purchase, Sweepstake, Departure and Airline Ticket Taxes Act <sup>First</sup>
