AN ACT to amend the Motor Vehicles and Road Traffic Ordinance, Ch. 16. No. 3.

[Assented to 18th June, 1976]

BE IT ENACTED by the Queen's Most Excellent Majesty, Enactment
by and with the advice and consent of the Senate and
House of Representatives of Trinidad and Tobago, and
by the authority of the same, as follows:—

1. This Act may be cited as the Motor Vehicles and Short title
Road Traffic (Amendment) Act, 1976.

2. The Motor Vehicles and Road Traffic Ordinance is amended—

- (a) by substituting the words "fifteen tons" for the words "ten tons" occurring in line two of paragraph (a) of subsection (1) of section 12;
- (b) by substituting the words "fifteen tons" for the words "ten tons" occurring in line five of subsection (3) of section 12;
- (c) by substituting for Item (4) of the First Schedule the following Item—
