THE MOTOR VEHICLES AND ROAD TRAFFIC ACT, CHAP. 48:50

ORDER

MADE BY THE MINISTER UNDER SECTION 65 OF THE MOTOR VEHICLES  
AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL ORDER, 2003

1. This Order may be cited as the Traffic Control Order, 2003. Citation

PART I

ST. HELENA

2. Taxis shall ply for hire as follows: Taxi-stands
- (a) taxis plying from St. Helena to Curepe shall park on the western side of Maheepat Road, facing north, to accommodate five taxis as marked;
  - (b) taxis plying from St. Helena to Las Lomas shall park on the northern side of Caroni Road, east of St. Helena Junction, facing east, to accommodate ten taxis as marked; and
  - (c) taxis plying from St. Helena to Arouca shall park on the eastern side of Golden Grove Road, facing south, to accommodate eight taxis as marked.

PART II

TUNAPUNA

3. Motorists proceeding in a westerly direction along the Eastern Main Road may turn right into— Right turn
- (a) Goya Road; and
  - (b) Caura Road.
4. Motorists shall proceed in both directions on Macoya Road Extension, between the Priority Bus Route and the Eastern Main Road. Two-way traffic
5. Motorists proceeding in a southerly direction on Macoya Road Extension shall not turn left into Back Street. No left turn
6. Motorists proceeding in a northerly direction on the Macoya Road Extension shall not turn left into Back Street. No right turn

- Taxi-stand            7. Taxis that ply the Tunapuna Round-the-Road routes shall park on the eastern side of Tunapuna Road facing south, to accommodate ten taxis as marked.
- Stopping or waiting prohibited            8. Motorists shall not stop or wait on Macoya Road, for a distance of one hundred metres south of its intersection with the Priority Bus Route.
- No entry            9. Motorists shall not proceed—  
     (a) in an easterly direction on Wilkinson Street, between 7.00 a.m. and 9.00 a.m. from Mondays to Fridays, except on Public Holidays, from Clementy Street to Jordan Street; and  
     (b) in a northerly direction on Jordan Street, between 7.00 a.m. and 9.00 a.m. from Mondays to Fridays, except on Public Holidays, from Wilkinson Street to the Eastern Main Road.

## PART III

## ST. JOSEPH

- No entry to goods vehicles exceeding eight thousand kilograms            10. Goods vehicles exceeding a maximum gross weight of eight thousand kilograms shall not proceed in a southerly direction along Abercromby Street, between Riverside Road and the Eastern Main Road.

## PART IV

## VALENCIA

- Parking prohibited            11. Parking is prohibited on the Eastern Main Road, from the Valencia Junction to a point one hundred metres westwards on the northern side.

## PART V

## FIVE RIVERS

- Taxi-stand            12. Taxis that ply the Five Rivers Round-the-Road route shall park on the southern side of First Street, facing west and accommodating eight taxis as marked.

## PART VI

## CARONI

- One-way traffic            13. Motorists shall proceed—  
     (a) in a northerly direction on the Caroni Bailey Bridge; and  
     (b) in a southerly direction on the Caroni Silver Bridge.

## PART VII

## PENAL

14. Taxis shall ply for hire as follows: Taxi-stand  
locations
- (a) a maximum of six taxis, on the western side of Winter Street, facing south;
  - (b) a maximum of four taxis, on the western side of Siparia Road, facing north; and
  - (c) a maximum of seven taxis, on the western side of Daisy Voisin Street, facing south.

## PART VIII

## PRINCES TOWN

15. Motorists shall proceed in a southerly direction on Charlotte Street. One-way  
traffic

## PART IX

## COUVA

16. Motorists shall proceed as follows: One-way  
traffic
- (a) in a westerly direction on Point Lisas Link Extension Road;
  - (b) in a northerly direction on Cumberland Street, between the Southern Main Road and Balisier Street; and
  - (c) in a northerly direction on Ramcharitar Street, between the hours of 6.30 a.m. and 8.30 a.m. and 2.00 p.m. and 4.00 p.m. from Mondays to Fridays, except on public holidays.

17. Parking is prohibited on Market Street, between the Southern Main Road and Exchange Lots Road. Parking  
prohibited

## PART X

## CHAGUANAS

18. Motorists shall proceed as follows: One-way  
traffic
- (a) in a southerly direction on the Southern Main Road, between the Chaguanas Main Road, at Busy Corner and Ramsaran Street;
  - (b) in a westerly direction on Ramsaran Street, between the Southern Main Road and Sati Pariagh Street;
  - (c) in a northerly direction on Sati Pariagh Street, between Ramsaran Street and the Chaguanas Main Road; and
  - (d) in a southerly direction on Marie Street, between Chaguanas Main Road and Eleanor Street.

- Parking prohibited
19. Parking is prohibited on—
- (a) Mulchan Siechan Road; and
  - (b) Parker Street between St. Yves Street and Rene Street.
- No entry to maxi-taxis
20. Maxi-taxis shall not enter—
- (a) Chaguanas, from the Interchange Exit at Bhagwansingh's Hardware to the north and at Seereeram's Gas Station to the south;
  - (b) Sati Pariagh Street, from Manick Street to the Chaguanas Main Road;
  - (c) Market Street, from Manick Street to the Chaguanas Main Road;
  - (d) Eleanor Street, from its intersection with Marie Street; and
  - (e) Marie Street, from Manick Street to Eleanor Street.
- Entry into Chaguanas
21. (1) Maxi-taxis operating along the Chaguanas to Port-of-Spain route shall enter Chaguanas by way of the Caroni Savannah Road, from either the Munroe Road or Endeavour Road Interchanges.
- (2) Maxi-taxis operating along the Chaguanas to San Fernando route shall enter Chaguanas by way of the Southern Main Road, at the Chase Village Triangle.
- Taxi-stands
22. Taxis shall ply for hire as follows:
- (a) taxis operating along the Chaguanas to Port-of-Spain route shall park facing south, on the western side of the Southern Main Road, south of the maxi-taxi hub to Ramsaran Street;
  - (b) taxis operating along the Chaguanas to San Fernando route shall park facing south, on the eastern side of the Southern Main Road, south of the maxi-taxi hub; and
  - (c) taxis operating along the Chaguanas to Felicity routes shall park on the eastern side of Marie Street, facing south, between the Chaguanas Main Road and Eleanor Street.
- Maxi-taxi stand
23. Maxi-taxis operating along the Chaguanas to Curepe routes shall park at the maxi-taxi hub at the Southern Main Road, by way of the entrance at Manick Street.

## PART XI

### CHAMPS FLEURS

- Parking prohibited
24. Parking is prohibited on Mt. d'Or Road, from the Eastern Main Road to a point fifty metres northwards.

PART XII

GENERAL

25. A person who contravenes any of the provisions of this Order is liable on summary conviction to a fine of five hundred dollars or imprisonment for three months.

26. Without prejudice to any other liability incurred by the omission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
