REGULATIONS

MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE MINISTER UNDER SECTION 67(1) OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME) (MARAVAL) REGULATIONS, 1994

1. These Regulations may be cited as the Traffic Control (Experimental Citation Scheme) (Maraval) Regulations, 1994.

2. These Regulations have effect from Tuesday, 1st March, 1994 to Tuesday, 31st May, 1994. Commencement and cessation

3. Parking is prohibited between the hours of 6.00 a.m. to 9.00 a.m. and 3.00 p.m. to 6.00 p.m. on Monday to Friday (except public holidays) on— Parking prohibited

- (a) Prada Street;
- (b) Rapsey Street, between Wainwright Street and Saddle Road;
- (c) Lamy Street;
- (d) Scott Street, between Wainwright Street and Newbold Street;
- (e) Wainwright Street; and
- (f) Saddle Road, between Maraval Road (St. Clair Roundabout) and Morne Coco Road.

4. Vehicular traffic shall proceed—

- (a) in a southerly direction on Saddle Road, between Rapsey Street and Maraval Road (St. Clair Roundabout) between the hours of 6.00 a.m. to 9.00 a.m. Monday to Friday (except public holidays); One-way traffic
- (b) in an easterly direction on Rapsey Street, between Wainwright Street and Saddle Road;
- (c) in a westerly direction on Prada Street, between Wainwright Street and Maraval Road;
- (d) in an easterly direction on Scott Street, between Wainwright Street and Newbold Street;
- (e) in a southerly direction on Maraval Road (St. Clair Roundabout), between Saddle Road and Prada Street, between the hours of 6.00 a.m. to 9.00 a.m. Monday to Friday (except public holidays);
- (f) in a southerly direction on Newbold Street, between Prada Street and Saddle Road; and
- (g) in an easterly direction on La Seiva Road, between Golf Course Road and Saddle Road, between the hours of 6.00 a.m. to 9.00 a.m. Monday to Friday (except public holidays).

Minor road 5. Long Circular Road at its intersection with Saddle Road is deemed a minor road.

6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
