THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(CHAGUANAS AND COUVA) REGULATIONS, 2001

1. These Regulations may be cited as the Traffic Control Citation
(Experimental Scheme) (Chaguanas and Couva) Regulations, 2001.

2. These Regulations shall have effect from 20th June, 2001 to Commence-

PART I

CHAGUANAS

3. Motorists shall proceed— One-way
traffic

(a) in a southerly direction along Southern Main Road between
Chaguanas Main Road (Busy Corner) and Ramsaran
Street;

(b) in a westerly direction along Ramsaran Street between
Southern Main Road and Sati Pariagh Street;

(c) in a northerly direction along Sati Pariagh Street between
Ramsaran Street and the Chaguanas Main Road; and

(d) in a southerly direction along Marie Street between
Chaguanas Main Road and Eleanor Street.

4. Parking is prohibited on— Parking
prohibited

(a) Mulchan Sieuchan Road; and

(b) Parker Street between St. Yves Street and Rene Street.

5. Maxi-taxis shall not enter— No entry to
maxi-taxis

(a) Chaguanas from the Interchange Exit at Bhagwansingh's
Hardware to the north and at Seereeram's Gas Station to
the south;

- (b) Sati Pariagh Street from Saith Park Street (Manick Street) to the Chaguanas Main Road;
- (c) Market Street from Saith Park Street (Manick Street) to Chaguanas Main Road;
- (d) Eleanor Street from its intersection with Marie Street; and
- (e) Marie Street from Saith Park Street (Manick Street) to Eleanor Street.

6. Route 3 maxi-taxis may ply for hire as follows:
- (a) maxi-taxis operating along the Chaguanas to Port-of-Spain route shall enter Chaguanas by way of Caroni Savannah Road from either Munroe Road or Endeavour Road Interchanges; and
 - (b) maxi-taxis operating along the Chaguanas to San Fernando route shall enter Chaguanas by way of Southern Main Road at the Chase Village Triangle.

7. Taxis plying for hire shall park as follows:
- (a) Port-of-Spain taxis shall park facing south along the western side of Southern Main Road, south of the Maxi-Taxi Hub, until Ramsaran Street;
 - (b) San Fernando taxis shall park facing south along the eastern side of Southern Main Road, south of the Maxi-Taxi Hub;
 - (c) Felicity taxis shall park facing south along the eastern side of Marie Street between Chaguanas Main Road and Eleanor Street; and
 - (d) Route 3 maxi-taxis shall park at the Maxi-Taxi Hub at Southern Main Road by way of the entrance at Manick Street.

PART II

COUVA

One-way
traffic

8. Motorists shall proceed—
- (a) in a northerly direction along Cumberland Street between Southern Main Road and Balisier Street; and
 - (b) between the hours of 6.30 a.m. to 8.30 a.m. and 2.00 p.m. to 4.00 p.m. in a northerly direction along Exchange Lots Road.

9. Parking is prohibited on Market Street between the Couva Main Road and Exchange Lots Road. Parking prohibited

PART III

GENERAL

10. Any person who contravenes any of the provisions of these Regulations is guilty of an offence and is liable on summary conviction to a fine of one thousand dollars. Offence

11. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
