MADE BY THE COMMISSIONER OF POLICE WITH THE CONSENT OF THE
MINISTER OF WORKS AND TRANSPORT UNDER SECTION 67(1) OF
THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (EXPERIMENTAL SCHEME)
(CUREPE/SADDLE ROAD/EASTERN MAIN ROAD, ARIPO)
REGULATIONS, 2010

1. These Regulations may be cited as the Traffic Control ^{Citation}
(Experimental Scheme) (Curepe/Saddle Road/Eastern Main Road,
Aripo) Regulations, 2010.

2. These Regulations shall have effect from Monday 30th August, ^{Duration}
2010 to Sunday 28th November, 2010.

PART I

CUREPE

3. Maxi-taxis that ply the Curepe to Chaguanas route shall ply on ^{Maxi-taxi stand}
the northern and southern lanes of Havelock Street, facing east,
between Southern Main Road and Broome Street.

4. Maxi-taxis that ply the Curepe to Chaguanas route shall not ^{No entry to}
enter— ^{maxi-taxis}

- (a) Southern Main Road, between Eastern Main Road and Havelock Street;
- (b) Broome Street, between Havelock Street and Evans Street;
- (c) Market Street, between Havelock Street and Evans Street;
- (d) Phillip Street, between Southern Main Road and McDonald Street;
- (e) Harris Street, between Southern Main Road and McDonald Street;
- (f) Clifford Street, between Southern Main Road and McDonald Street;
- (g) McDonald Street, between Phillip Street and Evans Street;
and
- (h) Evans Street East, between Clifford Street and Southern Main Road.

- One-way traffic 5. Motorists shall proceed in an easterly direction on Havelock Street, between Southern Main Road and Broome Street.
- No plying for hire 6. Taxi-drivers may not ply for hire their taxis or maxi-taxis on Broome Street, between Fowler Street and Havelock Street.
- Parking prohibited 7. Parking is prohibited on Agostini Street, Curepe, from Evans Street to a point two hundred metres eastwards.

PART II
SADDLE ROAD

- Parking prohibited 8. A person shall not park on Saddle Road—
 (a) between Blanc Street, and Sinanan Street; and
 (b) between Sam Boucaud Extension and Cantaro Extension.

PART III
EASTERN MAIN ROAD

- Stopping or waiting prohibited 9. Motorists are prohibited from stopping or waiting on the northern and southern sides of Eastern Main Road to a point one hundred and fifty metres east and to a point one hundred and twenty metres west of the main driveway of the Immigration Detention Centre (IDC), Aripo.

PART IV
GENERAL

- Offence and penalty 10. A person who contravenes any of the provisions of these Regulations is liable on summary conviction for a first offence to a fine of seven hundred and fifty dollars and on any subsequent conviction to a fine of one thousand dollars.
- Removal and impounding of vehicles unlawfully parked 11. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of these Regulations, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
