REPUBLIC OF TRINIDAD AND TOBAGO

Act No. 20 of 2000

[L.S.]

AN ACT to amend the Motor Vehicles and Road
Traffic (Enforcement and Administration) Act,
Chap. 48:52.

[Assented to 13th July, 2000]

ENACTED by the Parliament of Trinidad and Tobago as Enactment
follows:—

1. This Act may be cited as the Motor Vehicles and Short title
Road Traffic (Enforcement and Administration)
(Amendment) Act, 2000.

Interpretation
Chap. 48:52

2. In this Act, the Motor Vehicles and Road Traffic (Enforcement and Administration) Act is referred to as “the Act”.

Section 2 amended

3. Section 2 of the Act is amended—

(a) by deleting the definitions of “notice” and “registered owner” and substituting, respectively, the following definitions:

“ “notice” means a notice issued under section 3 and includes duplicate of such notice;

“owner” has the meaning assigned to that expression by section 2 of the Motor Vehicles and Road Traffic Act”;

(b) by inserting in the appropriate alphabetical positions, the following definitions:

“The Licensing Authority” has the meaning assigned to it by section 2 of the Motor Vehicles and Road Traffic Act;

“traffic” has the meaning assigned to it by section 2 of the Motor Vehicles and Road Traffic Act;

“traffic warden” has the meaning assigned to it by section 2 of the Motor Vehicles and Road Traffic Act;

(c) in the definition of “constable”—

(i) by deleting the full-stop in paragraph (iii) and substituting the following words: “; and” and

(ii) by inserting after paragraph (iii) the following paragraph:

“(iv) a traffic warden.”.

4. Section 3 of the Act is amended—

Section 3
amended

(a) in subsection (1)—

(i) by deleting the words “and notifying him that a complaint will be made against him in respect thereof”;

(ii) by deleting the word “complaint” and substituting the words “offence charged”;

(b) in subsection (2)(a) by deleting the words “registered owner” and substituting the word “owner”;

(c) in subsection (2)(b)—

(i) by deleting the words, “and notify him that a complaint will be made against him in respect thereof”;

(ii) by deleting the word “complaint” and substituting the words “offence charged”;

(d) in subsection (3) by deleting the words “registered owner” and substituting the word “owner”;

(e) in subsection (4) by deleting the words “, which duplicate shall be deemed to be a complaint laid before the magistrate”;

(f) by repealing subsection (5) and substituting the following subsections:

“ (5) The notice given or affixed or sent under this section deemed to be a complaint within the meaning of section 33 of the Summary Courts Act. Chap. 4:20

(6) Notwithstanding any written law to the contrary, the notice referred to in subsection (5) is, from the expiration of the time thereon specified for the payment of the fixed penalty,

deemed to be a summons issued in accordance with section 42 and served in accordance with section 43, respectively, of the Summary Courts Act.

(7) Notwithstanding any provisions of this Act or any written law to the contrary, a person who pays a fixed penalty before the expiration of the time specified for the payment thereof, may in the prescribed form, appeal to the Magistrate in the district in which he paid the fixed penalty in respect of the offence for which he was charged.

(8) Where in an action referred to in subsection (7) the Court decides in favour of the appellant, the amount representing the fixed penalty paid by the appellant shall be refunded to him.”.

Section 5 repealed
and a section
substituted

5. Section 5 of the Act is repealed and the following section is substituted:

“Payment of
fixed
penalties

5. (1) Where a notice has been given under section 3, the driver or the owner of the vehicle, as the case may be, may, subject to subsection (2), pay the fixed penalty in accordance with the notice.

(2) Payment of the fixed penalty shall be made to the Clerk having jurisdiction in the district in which the offence is alleged to have been committed.

(3) The time within which the fixed penalty is payable shall be fourteen days from the date of the notice, and where payment reaches the Clerk after that time, it shall not be receivable and shall be returned to the payer.

(4) Payment of the fixed penalty shall be accompanied by the notice completed by the driver or the owner as the case may be, in the manner prescribed.

(5) Where the fixed penalty is duly paid in accordance with the notice, no person shall then be liable to be convicted of the offence in respect of which the notice was given.

(6) A fixed penalty paid under this Act shall be dealt with in the same manner as payment of a fine imposed for an offence under the Summary Courts Act.”.

6. Section 7 of the Act is repealed and the following section is substituted:

7. Proceedings in respect of an offence deemed to be instituted by a notice under this Act shall not be listed for hearing in Court unless—

(a) a period of two months has elapsed from the last day on which the penalty is payable and the Clerk has no record that the fixed penalty was paid in accordance with section 5(3); and

(b) in respect of a notice issued under section 3(2)(a), the Clerk has been furnished by the constable, or the Licensing Authority with such information on the owner of the vehicle as would have been furnished to the Clerk had the notice been issued under section 3(1).”.

Section 11 amended **7.** Section 11 of the Act is amended by inserting after subsection (2), the following subsection:

“ (3) In relation to the system of awarding penalty points referred to in section 86A(2) of the Motor Vehicles and Road Traffic Act, the President may alter the number of penalty points for any offence so however that the penalty points for any offence do not exceed thirty points.”.

First Schedule repealed and a Schedule substituted **8.** The Act is amended by repealing the First Schedule and substituting the following Schedule:
